Introduction

Data Analysis

Is the core of the Pavement Management System. Without the ability to analyse the data the system becomes just a sophisticated repository for information on the network and the condition data that has been taken. The Confirm Data Transformation Engine is a highly sophisticated system that is able to analyse the data held way beyond the requirements of a standard Pavement management System. As with other parts of the Confirm functionality standard lookups tables or libraries have to be populated before the data analysis can take place.

Data Analyser

Takes selected Inventory and Survey condition data stored in Confirm and carries out calculations and transformations on it. The Data Analyser works by applying processes defined as Process Types to the data. These Process Types are made up using the rules and parameters held in the database. The Process Types are therefore rule sets that can be created by the user, or they can be standard rule sets provided by others (i.e. UKPMS Rules and Parameters). Confirm Pavement Manager stores the rules and parameters as data in the live user database. By storing the rules as data rather than being 'hard coded' in the Confirm software, it is easy for the user to update existing rules, or to modify these rules to suit local conditions and requirements. A rule may be as simple as a short calculation e.g. subtract cracked area from total area, to complex calculations involving multiple sets of data, algebraic operators, logical operators and transformation curves. These more complex operations are typical of those used in the UKPMS rule set to arrive at the required Performance Indicators and Treatment Options.

The data transformation engine that is the central core of the data processing system in Confirm essentially takes a condition data set held as a survey in the database and transforms it into a new data set using the defined rules and parameters. The new data is to all intents and purposes a new set of 'survey' type data. Confirm therefore treats these new data sets in exactly the same way as an original survey data set and uses the same functionality to access and store this data. For this reason, the data analysis functionality uses the concept of viewing and accessing processed data in the same way as original condition data through the same screens and lookups.

Security of Rules and Parameter Sets

Where the user requires the UKPMS rule set to calculate mandatory government indicators it is essential that the base rule set is not changed in any way. The system security should be set to ensure that the rules and parameters cannot be changed except by properly authorised users. It is further suggested that such users should only have access under a Login name and group that they do not use for normal day to day access. The user may also develop a new set of Rules and Parameters from scratch or import facilities can be used to enter other rule sets that may become available.

Data Analysis

The data Analysis screen is the start point for setting up the data analyser processing in Confirm.

The Data Analysis screen has two tabs Data Sets and Network Sections.

- Batch Number:** This number is allocated automatically by the system and is the next available number in the sequence, this number cannot be changed by the user. An attempt to add a new number results a warning.
- Name:** A 30 character description as appropriate for each Data Analysis set.
- External Ref.:** A 20 character description, this records an external reference for ease of referencing or cross referencing by the user. This is for information only and is not used by Confirm in any processing
- Notes:** Notes may be used to enter additional information about the analysis for future reference. This is a free text field of almost unlimited capacity.

Data Analysis - Delete Button

Clicking on the 'Delete' button in the Data Analysis screen entirely deletes the current Data Analysis from the database and the associated network sections, data sets and treatments that may have been saved.

A warning is issued before deletion.

Data Analysis - Data Sets tab

Analysis can be carried out either on the initial data, or on any data sets created during an analysis.

On the Data Analysis form, select the Data Sets tab, and then select the data set from which the data analysis is to be started. If carrying out the analysis for the first time, there will be only one data set i.e. Initial Data.

This form displays details of each of the data sets in the analysis.

Batch, Name, Ext. Ref.: These are all automatically completed from the data entered on the parent Data Analysis screen

Sequence: Sequence shows the sequence number assigned to the current data set within the analysis by the system.

Origin: Origin shows the sequence number from which this data set was created. This is therefore blank for the initial data set.

Stage: Stage shows the stage number in the analysis process at which the data set was created.

Date: This initially is set to zero, the date can be set as required or will default to the day on which the analysis is first carried out.

Notes: A free form text description of virtually unlimited length. These are user defined notes to assist in identifying the data and processing as may be required.

Data Status: This indicates the current status of the data at the stage of processing being viewed. This can be chopped or not chopped.

The Network Sections tab shows the features being analysed.

To enter new network sections, click on the 'Clear/New' button, then choose the section you require, either by typing in entries for one or more of street, label and sequence number, or using the 'Pick' buttons. When using the 'Pick' buttons it is recommended that the Label 'Pick' button is used as this presents a filter form on which the streets can be filtered as well. If the Street 'Pick' button is used instead, the location still has to be filtered on a separate screen later.

When the Network Section is selected the remaining fields are automatically completed. There is no need to fill in the data in any of the fields in the lower parts of the form.

Pressing the 'Save' button will add the selected section to the list and display a blank form for another entry.

To remove a section from those selected, either use the navigation buttons to locate the required entry, or use the 'Find' button .

Once the required section is displayed, click on the 'Delete' button and it will be removed from the selection.

When the adding or removing sections has been completed, click on the 'Close' button to return to the Data Analysis form. If the last entered details have not been saved by clicking on the 'Save' button the system will show a warning enabling the user to save the last added data (or not) as may be required.

Analysis Data Set - Processes Tab

The Processes tab shows the processes that have been carried out on the data set to create the current set from its origin set. The order of processing and the Parameters details are also shown.

When looking at an initial data set, there will be no data under processes.

There are a number of functions available which are accessed by clicking the Action Button.

Run Processes

Choosing Action, Run Processes will display the Process Run Filter.

Process: Displays the process type defined in the Data Analysis screen.

Log File: Provides the facility to write a text based output log of analysis activity/steps. This may be useful for checking correct processing of new rules and parameters, or if unexpected results are encountered.

Enter a path and file name. If using the Pick button, you must select an existing file to which the log is to be written.

Note: The log file can become very large where large amounts of processing take place so care needs to be exercised when using this feature.

Ignore Inventory: By Default, Confirm uses Inventory data to qualify the defectiveness and Feature Group of Observations for Analysis, and also in the estimation of Treatment costs. By ticking this option it is possible to run an Analysis ignoring Inventory data altogether.

Sub-Process: Shows the action that will be carried out by the process highlighted in the window at the bottom of the screen. The adjacent fields also show the process stage number and a second field to change the process order number.

The Sub-Process can be changed using the drop down to any of the available defined types.

Parameters: Shows the selected parameters where appropriate for the currently selected process.

The Parameter may be changed by pressing the Params button. This will bring up the Parameters Screen. From here you can either select from a drop-down list for Rule Sets, or enter values for other Sub-Processes.

Save: Allows the data save status to be changed at any of the stages using the drop down.

Process Run Filter - Add Button

Clicking on the Add button places a new process record at the end of the processes shown in the bottom part of the screen. The process stage number can be entered but does not alter the process positions shown in the window.

Process Run Filter - Delete Button

Clicking on the Delete button will delete the process currently highlighted in the bottom part of the screen. NB There is no associated warning before the delete action takes place. If a Process is deleted in error the Run Process Filter should be Cancelled and the Process re-started.

Process Run Filter Repeat Button

This button allows stages within the processing to be repeated a number of times. This functionality is not used for Tranche 2 processing.

Process Run Filter - Run Processes

To run the process, click on the OK button The processing will then begin. This may take some time, as a number of operations will have to be carried out on all of the sections selected for processing.

When processing has finished, the system returns to the Analysis Data Set window where now there are more data sets displayed, one for each stage at which data was saved.

Analysis Data Set Processes Tab

When the analysis has been completed the Processes tab on the Analysis Data Set screen displays a list of processes that were carried out on the data between this and the previous set. (For a data set other than the initial set).

A record is saved each time a data set is saved. Examining each of the Analysis Data Set records for an analysis shows the complete set of processes from start to finish.

SCANNER Road Condition Indicator

When running a SCANNER analysis it possible to record intermediate values during the calculation, if appropriate Observation Types exist.

For a Defect involved in the SCANNER calculations, the weighted value will be saved to the Observation Type whose code is 'SW' plus the Defect Code, if it exists. So for example the weighted value of LLRT will appear in the results Data Set as an SWLLRT Observation.

The Family Values generated during the SCANNER calculations will be saved to the Observation Type whose code is 'SF' plus an abbreviation of the Family ID, i.e. Rutting - SFRUTT, Texture - SFTEXT, CrackingWC - SFCWC, CrackingWT - SFCWT, LPV - SFLPV, LPV3 - SFLPV3, and LPV10 - SFLPV1.

Note: Saving the intermediate values may impact the performance of the analysis due to the extra data being saved. Once these Observation Types have been created, it is possible to suppress saving of the intermediate values by setting the Observation Types as Dead.

Cost Codes

Selecting Action, Cost Code in the Analysis Data Set screen displays the Survey Cost Code Batch Filter. This is used to update individual cost codes of generated treatments for individual streets. Refer to the Confirm Site Register Manual section for more details.

Edit Treatments

Use the Edit Treatments option to manually edit details of generated treatments, e.g. to change individual cost codes.

Budget Optimisation

Selecting Action, Budget Optimisation in the Analysis Data Set screen displays the Treatment Optimisation Filter. This is used to prioritise treatments on their ranking and allocate their costs against a set budget.

Save Conditions

Choose "Action/Save Conditions" from the Analysis Data Set screen to create Feature Conditions based on observations, e.g. the Structural Condition Index (aggregated to whole Section length).

Reset Analysis

Where only some of the saved data sets in an analysis require to be cleared or reset then a Reset Analysis option is available from the Analysis Data Set screen. This feature resets the data set associated with the current Data Set record screen and all subsequent data sets (if any).

The action of this function and warning screens displayed are the same as from the Data Analysis screen except for the limitation on the data sets that are reset.

Data Analysis - Network Sections Tab

As well as using Batch Add Features, features may be added or deleted one at a time, by selecting the Network Sections tab in the Data Analysis screen and clicking on the Detail button .

To enter new network sections, click on the Clear/New button, then choose the section you require, either by typing in entries for one or more of street, label and sequence number, or using the Pick buttons. When using the Pick buttons it is recommended that the Label Pick button is used as this presents a filter form on which the streets can be filtered as well. If the Street Pick button is used instead, the location still has to be filtered on a separate screen later.

When the Network Section is selected the remaining fields are automatically completed. There is no need to fill in the data in any of the fields in the lower parts of the form.

Pressing the Save button will add the selected section to the list and display a blank form for another entry.

To remove a section from those selected, either use the navigation buttons to locate the required entry, or use the Binoculars button.

Once the required section is displayed, click on the Delete button and it will be removed from the selection.

When the adding or removing sections has been completed, click on the Close button to return to the Data Analysis form. If the last entered details have not been saved by clicking on the Save button the system will show a warning enabling the user to save the last added data (or not) as may be required.

Data Analysis - Action Button

Batch Add Features

Choosing Action, Batch Add Features from the dropdown menu will display the Feature Filter form, which is used to select the Network Sections to include in the analysis. The features chosen for basic analyses will be the network sections on which the condition data is based, at present Confirm Pavement Manager will only allow the selection of Network Sections no matter which feature group is chosen.

Note: If the Save button has not been used after completing the base information on the form the following warnings are displayed by Confirm as the validation procedures check the data. Firstly, the standard warning asking whether the user intends to save the just entered data is issued.

The Batch Add Features option can be used more than once to add Network Sections from different areas or under different lookup headings as required. However, where regular processing of these same sets of sections is to be carried out it is suggested that the Named Selection option is used to enable quick and easy repetition of the same selection. Once saved there is no option to remove sections so if unwanted sections are added the only option is to discard the analysis record and add the sections again.

Only Features classified as “Linear” are added to the analysis, other types are automatically filtered out.

Refresh Data

When all the Network Sections (Features) on which the analysis is to be carried out have been selected, clicking on Action, Refresh Data will display the Refresh Data Filter.

The Refresh Data Filter is used to select and add Survey condition data from the various surveys currently held in Confirm against the Network Sections already selected.

Load Type: Select one of the following option to specify which data to select for analysis: Current Data – Selects the latest data per Feature/XSP. All Data – Selects all survey data within the specified data ranges.

Ignore Inventory: By Default, Confirm uses Inventory data to qualify the defectiveness and Feature Group of Observations for Analysis. By ticking this option it is possible to run an Analysis ignoring Inventory data altogether.

Create Whole Length Observations: Creates an observation on the whole length for each Feature. See **Data Analyser System Settings** for more details.

Suppress Refresh Warnings: Ticking this option stops logging warnings during Refresh process. It helps speed up the process in case large number of warnings is being recorded.

- Weighting Set File:** Optionally locate the Access database file containing Weighting Sets for SCANNER Road Condition Indicator analysis.
- Note:** If a Weighting Set is specified then only observations required by that Weighting Set will be copied to the Analysis. This significantly improves the performance of the Refresh Data process and requires less database storage.
- Weighting Set Id:** Most Weighting Set Files contain a single Weighting Set which will be shown here. In the event of a file containing multiple Weighting Sets, use this to select the correct one.
- All:** Select this to tick/un-tick all of the Survey Types in the list below.
- Add button:** Click the 'Add' button to add an extra line to the filter. This then allows the User to select an additional Survey Type. The Group and Priority can then be set. The same Survey Type can be allocated to several Groups with different Priorities if required.
- Delete button:** Clicking 'Delete' will remove the currently selected Survey Type from the list.

This filter also allows for selection based on groups of various Survey Types. The variables taken into account are the specified Priority within the Group, the specified Effective Dates and the Cutoff Dates.

- Include:** Tick the required Survey Types to be included in the Data Analysis. These can be all ticked/un-ticked with the 'All' checkbox.
- Survey Type:** Select the required Survey Type in the drop down.
- Group:** Supply a numeric value to group the Survey Types. The grouping system is used to allocate Priority to the various Surveys that may be available where the processing to follow requires, say, only the most recent Survey or one particular Survey takes precedence over another based on type and/or age.
- Priority:** Supply a numeric value to give this Survey Type a Priority within the Group that it has been assigned to. When refreshing the data, Confirm will look for a Survey from within each Group, starting with the Survey with Priority 1. If no Surveys of that type are located, it will look for a Survey of priority 2. When more than one Survey of the same Priority is found within a Group, the Survey with the most recent date will be chosen.
- Cutoff Date:** Supply a Cutoff Date to limit the age of Survey that will be considered by the Analysis. If a date is entered, no Survey carried out before that date will be selected.
- Effective Date:** Supply an Effective Date to give Confirm a date at which a Survey needs to have been effective. This defaults to the current date, but may be used, for instance, to run a report showing what condition the network was in at a past date.

Run Processes

Choosing Action, Run Processes will display the Process Run Filter.

Note: FOR PREDEFINED PROCESSES TO CONFORM TO THE SET STANDARDS YOU MUST NOT ALTER THE PROCESSES THAT ARE ALREADY SET.

Process: Displays the process type defined in the Data Analysis screen.

Log File: Provides the facility to write a text based output log of analysis activity/steps. This may be useful for checking correct processing of new rules and parameters, or if unexpected results are encountered.

Enter a path and file name. If using the Pick button, you must select an existing file to which the log is to be written.

Note: The log file can become very large where large amounts of processing take place so care needs to be exercised when using this feature.

Ignore Inventory: By Default, Confirm uses Inventory data to qualify the defectiveness and Feature Group of Observations for Analysis, and also in the estimation of Treatment costs. By ticking this option it is possible to run an Analysis ignoring Inventory data altogether.

Sub-Process: Shows the action that will be carried out by the process highlighted in the window at the bottom of the screen. The adjacent fields also show the process stage number and a second field to change the process order number.

The Sub-Process can be changed using the drop down to any of the available defined types.

Parameters: Shows the selected parameters where appropriate for the currently selected process.

The Parameter may be changed by pressing the Params button. This will bring up the Parameters Screen. From here you can either select from a drop-down list for Rule Sets, or enter values for other Sub-Processes.

Save: Allows the data save status to be changed at any of the stages using the drop down.

Process Run Filter - Add Button

Clicking on the Add button places a new process record at the end of the processes shown in the bottom part of the screen. The process stage number can be entered but does not alter the process positions shown in the window.

Process Run Filter - Delete Button

Clicking on the Delete button will delete the process currently highlighted in the bottom part of the screen. NB There is no associated warning before the delete action takes place. If a Process is deleted in error the Run Process Filter should be Cancelled and the Process re-started.

Process Run Filter Repeat Button

This button allows stages within the processing to be repeated a number of times. This functionality is not used for Tranche 2 processing.

Process Run Filter - Run Processes

To run the process, click on the OK button The processing will then begin. This may take some time, as a number of operations will have to be carried out on all of the sections selected for processing.

When processing has finished, the system returns to the Analysis Data Set window where now there are more data sets displayed, one for each stage at which data was saved.

Analysis Data Set Processes Tab

When the analysis has been completed the Processes tab on the Analysis Data Set screen displays a list of processes that were carried out on the data between this and the previous set. (For a data set other than the initial set).

A record is saved each time a data set is saved. Examining each of the Analysis Data Set records for an analysis shows the complete set of processes from start to finish.

SCANNER Road Condition Indicator

When running a SCANNER analysis it possible to record intermediate values during the calculation, if appropriate Observation Types exist.

For a Defect involved in the SCANNER calculations, the weighted value will be saved to the Observation Type whose code is 'SW' plus the Defect Code, if it exists. So for example the weighted value of LLRT will appear in the results Data Set as an SWLLRT Observation.

The Family Values generated during the SCANNER calculations will be saved to the Observation Type whose code is 'SF' plus an abbreviation of the Family ID, i.e. Rutting - SFRUTT, Texture - SFTEXT, CrackingWC - SFCWC, CrackingWT - SFCWT, LPV - SFLPV, LPV3 - SFLPV3, and LPV10 - SFLPV1.

Note: Saving the intermediate values may impact the performance of the analysis due to the extra data being saved. Once these Observation Types have been created, it is possible to suppress saving of the intermediate values by setting the Observation Types as Dead.

Add Data from Analysis

This is achieved using the Action button and selecting the Add Data from Analysis option with the Data Sets Tab viewed.

When the Data Set has been selected clicking on the 'OK' button results in any data that exists for the Network Sections selected in the new Data Analysis being copied to the new Initial Data set.

The warning screen detailing the features updated or that no features have been updated is then displayed.

Examining the Initial Data set at the Survey Section screen level shows the addition of the previously analysed data.

Clear Data

Where the Initial Data that has been added to a data analysis needs to be changed the existing data must first be removed. This is achieved using the 'Action' button and selecting the 'Clear Data' option with the Data Sets Tab viewed. The data is then automatically cleared without further warning or user intervention. Alternatively using the 'Refresh Data' option will also clear the existing data.

Reset Analysis

The Clear Data option only operates on clearing the initial data set. If there are saved data sets from processing these have to be cleared before the Initial data set can be cleared or refreshed. The analysed data sets may also be very large and cause the database to become unnecessarily large. The Reset Analysis option provides the facility to delete all the data sets and associated observations apart from the initial data set. Once this action has been carried out the Initial data set can be cleared or refreshed.

This is achieved using the 'Action' button and selecting the 'Reset Analysis' option with the Data Sets Tab viewed. The data is then cleared after issuing a warning.

Data Analyser Reports

The Confirm Data Analyser provides comprehensive reporting facilities to produce text reports from within Confirm and for exporting data to other software products as well as diagrams and spatial representation (GIS) (see **Displaying Linear Feature Data in Map**). The Data Analyser reports can be used in conjunction with the reports available from the Network Manager, Network Reports section.

Street Section Condition Summary

The Street Section Condition Summary provides a report summarising the network condition by Observation Type and Parameter for individual Street Sections and the associated Feature Groups.

The report will list Data Analysis and/or Survey records for a single Survey and Data Set or all Surveys and Data Sets at a time. Use of the Street and Named Selection options on the filter are recommended for the avoidance of excessively large reports.

Note: Survey status must be selected as either 'Loaded into Edit Area' or 'All' for data to be returned.

A similar report, grouped at Network level is available by running the **Network Condition Summary**.

Street Section Current Condition

Completing the appropriate fields to restrict the report listing then clicking on the OK button commences the report processing. In order to report only on structural condition index the correct surveys and observation type should be selected in the filter.

Multiple Observations List

This report can be used to provide a listing of survey observations from either a single survey or a number of surveys or analyses.

External Network Section Current Condition

This report allows reporting on the Current Condition of External Network Sections.

Survey Data Set List

This report may be used to provide a listing of the processed data from analyses, a range of Data set may also be specified.

Data Set Process List

This report is used to list the various stages undertaken by each process of analyses.

Budget Optimisation Report

This report is used to provide the priority lists of those parts of the Network requiring treatment. This is essentially the 'worst first' priority listing. It also gives estimated costs for each treatment.

For this report to be used successfully the Data set selected must be one that has Treatment selection processing. For Standard UKPMS processes this is normally the last data set. Additionally the Cost Codes attached to the Network Sections must have been set up, unit costs entered in the Target Cost field of the Treatment SOR item (found under Asset Maintenance on the Confirm Explorer) and a Budget Instance defined.

Once the Budget Optimisation Report has been run, you will be able to save the resulting Funding Status. On exiting the report, the system will prompt you to save changes. Doing so will replace the previous funding status of the treatments.

Survey Treatment Summary

This report provides a summary of the treatment costs against each cost code, indicating the total costs of funded and unfunded treatments.

Survey: The Survey (Analysis) from which the appropriate treatment data set is to be used is selected by entering a known Survey number or by using the Pick button and associated Survey Lookup table.

Data Set: The appropriate treatment data set is now selected using the drop down of available data sets. For this report to be used successfully the Data set selected must be one that has Treatment selection processing. For Standard UKPMS processes this is normally data set 5.

Live at Date: A date can be selected in the usual way to report on historic treatment scenarios.

Budget Instance: Select the required Budget Instance.

Survey Treatments by Street Section

This report provides a list of all treatments in an analysis dataset, grouped by Section.

Strategy Observation list

This report may be used to provide condition data over time under different treatment strategies.

Strategy Treatment list

This report shows all treatments generated by a strategy.

Network Performance List

This report provides a summary of the average condition over time for different strategies.

Feature Length by Condition List

Similar to the Feature Current Condition report, except a single Observation Type must be selected on the filter. The data is then displayed in descending order of this Observation Type. This report also details Treatments for each length.

Network Indicator List

Used for the production of National Indicator reports. For further details on producing these reports see **UKPMS Indicator Reports**.

It is not used to provide financial information for asset management. For further details about which reports to use for this see **UKPMS Financial Information**.

At the top of the filter, you may select the specific Streets or Network Sections to be reported on. The middle section is used to select the specific Survey data required and the lower section specifies the report that is to be produced and the data that is to be used.

All Report Types default to showing lengths in kilometres to 3 decimal places. The filter allows lengths to be shown in metres instead of kilometres, however the report will be classed as 'Custom' if this is done.

Note: It is possible to change threshold values but not the Observation Type or operator.

Note: Filter criteria determined directly from the Report Type will be suppressed from appearing as filter criteria on the report itself. However, if a 'Customised' report is chosen, then these criteria will be shown.

Note: For the SCANNER based performance indicators (NI 168, NI 169, Scotland and Wales), specific Weighting Set files need to be used. These are supplied with Confirm in a 'SCANNER Weighting Sets' zip file. They are also available to be downloaded from the document library of the UKPMS section of the PCIS website (<http://www.pcis.org.uk>).

Network Survey Maintenance Need Report

This report displays suggested Treatment Information for the surveyed network.

The filter screen for the report is divided into two sections.

The top section allows individual Sites or Features to be selected. It also allows a Named selection to be specified.

The bottom section is where the source of data is selected. The Survey and Data Set details are mandatory. The Feature Group Like refers to the Feature Group of the Survey Observations.

Other fields in this section are:

- **XSP:** The various points on any cross section for a particular section, such as lane edge, kerb, footpath, etc. Here only the Survey Treatment details for the selected XSP type will be displayed.
- **SOR Group:** This corresponds to SOR Group Code for a Survey Treatment.
- **Chainage From and To:** This is used for specifying Survey Treatment Chainage range. Only those Survey Treatment records are retrieved for which end Chainage is greater than the value specified in the To field and start Chainage is less than that specified in the From field.
- **Date From and To:** The Effective Date Range for Survey Treatment.
- **Live at Date:** A date can be selected in the usual way to report on historic treatment scenarios.
- **Status:** Allocated status for Survey Treatment.

For each combination of Feature Hierarchy, Pavement and Generic Treatment the following information is displayed:

- **Treatment Length:** This is the total length of treatments suggested for features with defects.
- **Treatment Area:** This is the total area of suggested treatments.

The report can be used to provide treatment information on many different parts of the network, but its primary purpose is to assist with the provision of financial information for UKPMS to support asset maintenance for footways, cycletracks and paved verges. For further details see **UKPMS Financial Information**.

Network Depreciation Report

(Asset Valuation module)

This report shows a summary of accumulated depreciation for the network, with summary data shown for groups of data defined by the user.

It can be used in the UK to provide depreciation calculations for Carriageway based on a Carriageway Condition Index (CCI) value derived from SCANNER, CVI or DVI Survey data. For further details see **UKPMS Financial Information**.

The filter screen for the report is divided into three sections. The top section allows Feature selection criteria to be entered. The centre section is used to select the Analysis data to be included. The bottom section allows the user to specify how data in the report is to be grouped, by specifying up to two criteria to define the groups, and how width and depreciation calculations should be carried out for each group.

- **Use Measured Inventory:** If this is ticked the report will attempt to calculate the Average Width for this group based on Inventory data.
- **External Width:** This value will be used if the above is not ticked, and for Features with no Inventory.
- **Asset Category:** This determines the Useful Life, Initiation Period, Replacement Unit Cost, and Residual Unit Cost used in depreciation calculations.

Buttons: OK, Cancel, Clear, Preview

The report displays a row for each combination of the specified grouping criteria. For example if the user chose to define the groups by 'Urban or Rural' and by 'DfT Classification' there will be one row for 'Urban' class '3' Features, one for 'Urban' class '4' Features, and so on.

For each combination, the information described below is shown.

- **Network Length:** The total number and length of Features in this group.
- **Average Width:** A representative Average Width for all the Features in the group, used to calculate a total quantity. The report also shows whether, for this group, the Average Width has been derived from Measured Inventory data, an External value entered by the user, or a combination.
- **Initiation Period (T_{INI}):** The time (in years) to when deterioration commences for the Asset Category entered by user.
- **Useful Life (T_{ULF}):** The time (in years) to when the pavement is unserviceable and needs replacement for the Asset Category entered by user.
- **Renewal Unit Rate:** The average surfacing renewal rate. (Replacement Unit Cost – Residual Unit Cost)
- **Survey Coverage:** The length of Features in this group included in the Analysis data, and the percentage of the Network Length in the group that this represents.
- **Depreciation (%):** For each Feature in a group, the report estimates the percentage of the way through its Useful Life the Feature is, based on the Condition value in the Analysis results. The Depreciation (%) shown for each group is the length weighted mean of the values of all Features within the group.
- **Depreciation:** The monetary value represented by the above percentage. This is calculated as (Length x Width x Unit Cost) x Depreciation (%).
- **Annual Depreciation:** The depreciation for one year of life of all Features in the group. This is calculated as (Length x Width x Unit Cost) / Useful Life.

A row of summary values is also shown for the data grouped by each of the selected grouping criteria separately. For example if the user chose to define the groups by 'Urban or Rural' and by

'DfT Classification' there will be one summary row for each value of 'Urban or Rural' and also one summary row for each value of 'DfT Classification' in the data.

A single row of overall summary values is also shown.

A particular group may be excluded from the calculation of summary values for Depreciated Value and Annual Depreciation because of two reasons:

- **A warning Message "Excluded - no width available"**: Means that an Average Width could not be calculated for the group, because "Measured Inventory" is not ticked or at least one Feature has no Carriageway Inventory, and no External Width is entered.
- **A warning Message "Excluded - no Survey Coverage"**: Means that for this particular group no Survey data is available to be used in Depreciation calculations.

Network Condition Summary

This report shows a Condition Summary similar to the **Street Section Condition Summary** on page 22 grouped at Network Level.

Network Analysis Data Export

This utility is for interfacing with HDM4. This exports analysed data to an HDM4 network .dbf file.

Note: This is not used for UKPMS

UKPMS Indicator Reports

Introduction

This guide is to assist in the production of UKPMS reports using Confirm. It provides information on the steps required and links to other relevant sections of the Confirm Help.

The steps to produce most of the UKPMS Indicators are as follows:

- Import the Rules and Parameters
- Import the Survey Data
- Set up a Data Analysis record
- Specify the Features to be included
- Specify the Condition Data to be included
- Run the Analysis
- Generate the report

The importing steps are usually performed just once at the beginning of the process and the analysis and running of the report done for each report required.

Note: The Footway Network Survey Headline Indicator is produced directly from Condition Data without the need to perform a Data Analysis. See the **Footway Network Survey** for more details.

Import the Rules and Parameters

Before performing any UKPMS analysis the Rules and Parameters for the current year must be imported into the database. The Rules and Parameters are provided in Microsoft Access database format and the File is named to reflect the year the rules are designed for (e.g. RP10.01 for use in 2010 and onwards).

See **Data Analyser Imports** for more information.

Import the Survey Data

Survey data should be supplied in HMDIF format and the Importing is explained in the **Import Survey Data** section.

Set up a Data Analysis record

All analysis is done using the **Data Analysis** screen. Set a Name for the new analysis (Batch No. is generated automatically).

Two types of analysis are performed in order to produce the UKPMS reports; Automatic Pass and SCANNER Road condition Indicator analysis. The report being run will determine which type of analysis data is used, but the analysis must be run in advance of the reports being run as the reports simply display the results of the different analysis.

When performing an analysis you must specify how the data will be analysed by setting the 'Process Type'. The analysis for UKPMS requires that the Rules and Parameters for the current year be imported before performing the analysis. There are two types of Automatic Pass analysis in common use by UKPMS; fixed length and variable length. The other process type used by UKPMS is 'SCANNER Road condition'. These types are created automatically by the Rules and Parameters Import and the type required will depend on the report being run.

Specify the Features to be included

A significant amount of processing effort is required to perform the analysis, especially the Automatic Pass analysis, so the processing time can be reduced considerably by only running the analysis for the Features that are to be reported on (rather than analyse lots of Features and filter them at the reporting stage). The Features to be analysed are set by the "Action" button "Batch Add Feature" option. This option will display a filter used to restrict the Features that will be included.

Named Selections are the easiest way of adding Features based on a multiple criteria (and the only way when certain Features must be removed from the selection i.e. roundabouts), but where the Feature selection is straightforward they can be filtered here.

The Feature data required by the UKPMS reports is often more varied than can be retrieved in a single filter operation. To overcome this, Named Selections are used to build up a list of the relevant Features by performing multiple filter operations. Further details on creating Named Selections can be found in the **Named Selection Tool** section of the help.

Most Named Selections created for the UKPMS reports will be a collection of one or more DfT classifications (in some databases this is named DOT Classification), although some also require that roundabouts be removed and some are based on inventory. The particular report section will provide exact details of creating the Named selection for the report.

Note: It is important to remember that a Named Selection is a list of Features retrieved at the time it was created and the filter criteria used to create it is not remembered. This means any Features that are added or removed after creation will not be reflected in the Named Selection.

Specify the Condition Data to be included

Selecting the condition data to be included in the analysis is done using the "Action" button "Refresh Data" option. This will then display the 'Refresh Data' screen where the types of observation data and the date range required can be selected. Each UKPMS report will require specific observation types and ranges. An additional setting on this screen that is sometimes required by the UKPMS reports is the "Ignore Inventory" tick box. Again, whether or not it needs setting will be dependent on the report being run.

For SCANNER analysis, 'Refresh Data' can be also performed from '**Process Run Filter**' before specifying SCANNER Index. This will require parameters like survey type and dates to be specified similar to that on 'Refresh Data' screen'.

Run the Analysis

The Analysis is started by first selecting the 'Initial Data' on the 'Data Sets' tab and then clicking the detail button. This will display the 'Analysis Data Set' screen showing all of the Features with condition data that will be included in the analysis. From here select the 'Action' buttons 'Run Processes' option to open the '**Process Run Filter**' the Analysis is actually started and different options can be set that determine how the analysis will be performed in more detail.

If the report requires that Inventory be ignored then the 'Ignore Inventory' option should be ticked, just as it was in the 'Refresh Data' screen.

If a SCANNER type analysis is being performed then the Weighting Set to be used must be specified by clicking the 'Parms' button and locating the relevant Access database file.

For the UKPMS reports the Sub-Process setting should not be changed from the default.

Introduction

This guide is to assist in the use of Confirm to produce reports of financial information for asset management in support of the “Code of Practice on Transport Infrastructure Assets: Guidance to Support Asset Management, Financial Management and Reporting” published by CIPFA (2010).

Further information about the specific requirements, including details of the calculations, available from the UK Roads Liaison Group's website (www.ukroadsliaisongroup.org):

- Advice Note 9 - Part 1 - Carriageway Depreciation Calculations in UKPMS
- Advice Note 9 - Part 2 - Footway & Cycletrack Depreciation Calculations in UKPMS

There is a separate section explaining how this is done for each of the different types of Inventory.

UKPMS Financial Information for Carriageways

Calculating Accumulated Depreciation

Confirm provides the **Network Depreciation Report** which calculates accumulated depreciation based on Carriageway inventory data combined with a Carriageway Condition Index (CCI) calculated either from SCANNER data or from visual condition data processed using an Automatic Pass.

The report uses the Carriageway Condition Index (CCI) to estimate the age of each part of the Carriageway surface, and then uses that age to calculate the current accumulated depreciation.

Before running the report, it is necessary to decide on the network groupings that will be used to report the results. Typically network groupings will be defined using the combination of the 'Urban or Rural' and 'DfT Classification' Attributes. However, they can be defined in different ways, using up to two of the following values:

- Network Priority
- Feature Type
- Urban or Rural
- DfT Classification
- Speed Limit

For each network grouping that will be used, an **Asset Category** needs to be configured. This allows the following values, required by the depreciation calculations, to be specified for each network grouping:

- Renewal Unit Cost – the renewal cost per square metre of pavement
- Useful Life – the number of years after which the pavement is unserviceable and needs to be replaced
- Initiation Period – the number of years after which deterioration commences

Note: The Renewal Unit Cost is actually taken to be the difference between the Replacement Unit Cost and the Residual Unit Cost on the Asset Category screen. The latter can be left as 0.

Note: If two or more network groupings share the same values, a single Asset Category can be specified and used for several network groupings when running the report.

The report also requires an average Carriageway width for each network grouping in order to estimate the total quantity of pavement for that network grouping. The method used to calculate this can be specified when running the report.

For more details on running the report see **Network Depreciation Report**.

Calculating Annual Depreciation

An Annual Depreciation figure for each network group is also shown on the above report.

- Group Two - 'DfT Classification'

Calculating Annual Depreciation

For bituminous Footways the calculation of annual depreciation is based on a life cycle approach. This is currently outside the scope of UKPMS and Confirm does not contain functionality to support it.

For modular Footways Annual Depreciation is evaluated by considering the area of Footway needing treatment at the previous reporting date and comparing this with the area needing treatment at the current reporting date.

Data Analyser Lookups

Data Analyser Lookups are the lookups or libraries required to create a data analysis process. They contain the rules and parameters that form the algorithms used by the system. For standard UKPMS Rules & Parameters processing, all the lookups are populated with the current UKPMS rule set.

Where the user requires to carry out differing analyses using other rules and parameters then the existing Rule Set can be copied and the data in the copied set may be added to and edited as required. Confirm can hold as many rule sets as the user requires therefore it is recommended that the base rule set is not altered.

The Data Analyser operates on the survey condition data held in the database using the network section and inventory data in conjunction with the rules and parameters set. The analysed data produced is essentially modified condition data and is therefore logically held in the same form as condition data. For this reason the analysed data is held, edited and reported on in the same way as survey data using the same screens. It therefore also follows that the Data Analyser Lookups that refer to data held in this way are the same as or an extension of the Survey Lookups.

In the following section on the Data Analyser Lookups those lookup tables that correspond to the Survey Lookups are repeated in exactly the same detail as in the Survey Lookups section.

Please refer to the Condition Survey manual for details on Observation Type, Parameter and Impact. Please refer to the Asset Maintenance Manual for details on SOR Item and SOR Group.

Observation Type

Observation Type, used in conjunction with Observation Parameter and Observation Impact, set up the parameters for judging the condition of a Feature.

Where Observation Types are being used in the Risk module Observation Types define the Failure Modes, or the manner in which an Asset may fail, for example 'Structural', 'Capacity'.

Observations are usually carried out as part of a Condition Survey inspection (Condition Survey module). However, details for Feature condition can be entered directly against Features in the Asset Register, even when the Condition Survey module is not present.

The Observation Type will list the Condition Types that will be judged for a Feature.

- Aggregation:** Only relevant for the PMS Linear Assets module, this can be ignored for all other users.
- Select the method by which Observations of this Type being entered are combined when fitting them to fixed lengths, merging etc. Length Weighted Mean is the normal or most usual form of Aggregation for UKPMS.
- Default Value:** The numerical value that is assigned to this observation type as a default. (If other than zero).
- Condition Assessment:** Checked by default, and should not normally be changed.
- Failure Mode:** (Activity Log and Risk Assessment modules)

Base Date: (PMS)

Base Date is for use with Tranche 3 functionality - see relevant documentation for more details.

Observation Parameter

The Observation Parameters are the 'grades' that can be assigned to different Observation Types. Many of the conditions (Observation Types) that may be observed on a defect will be identical for many different Observation Types e.g. 'Good', 'Fair' and 'Poor'. By using Observation Parameters these grades only need be defined once and used on multiple Observations Types.

In addition to setting out the condition grades the Parameters allow for these grades to be scored. The score is also used to provide a 'Condition Rating' for the Feature and does this by applying a weighted value within a Feature Group e.g. a grade of 'Fair' providing a score of 5 will be multiplied by the weighted value specified in the Feature Group to provide a higher or lower score that contributes to the Features overall 'Condition Rating'.

Where Performance Monitoring is being used to monitor Features, as opposed to monitoring Works, the assigned grade can be used to generate Failure Notices, based on the value of the 'Acceptable' flag for the grade.

Note: Once created an Observation Parameter may continue to be changed until it is used. Once in use the value fields will no longer be editable and it may not be possible to add more Options.

Process Type is used to define the steps carried out in a process. It enables predefined processes to be set up for repeated use in the Data Analyser. These may be standardised processes as required by central government (e.g. Automatic pass) or can be a user-defined process appropriate to local requirements.

Dead: Clicking on the checkbox marks the process type as 'Dead'. It will no longer appear in drop down lists, however, the details remain in Confirm.

Process Type - Detail Button

 - 'Calculate Benefit' - (Module 2210) For use with Treatment Effects. Calculates an overall benefit and economic cost for each of the Strategies that has been created, relative to the base 'Do Nothing' Strategy. These can then be used in Econometric Prioritisation of the Strategies.
 - 'Chop' - (Module 4310) This chops all observations where any observation on the same cross section changes. The resulting lengths are consistent in all observations over their entire length.
 - 'Condition Projection' - (Module 2020) Estimates current condition by projecting based on Observation data from one or more historical Surveys.
 - 'Create Strategies' - (Module 2210) For modelling alternate Treatment Strategies over time, this makes copies of the data so that projection can be continued into the future for the situation where no Treatment is carried out, and for the situations where a Treatment is carried out in year one, two, three and so on.
 - 'Discard Conflicts' - (Module 4010) If observations on the same length have different feature groups then one feature group is chosen (the one with the highest value of any observation) and all the rest are discarded.
 - 'Fixed Lengths' - (Module 4310) This takes all the observations present and aggregates/chops them to the specified lengths. This results in chopped data.
 - 'Increase Date' - (Module 2210) When modelling changes in values over time, this is used to increase the effective date by 1 year so it can be used in calculations. E.g. age of a Carriageway in the projected year.
 - 'Merge' - (Module 4310) This merges each observation type separately. This generally results in unchopped data.
 - 'Preset Lengths' - (Module 4310) This takes all the observations present and aggregates them to the lengths of a specified survey and data set. This results in chopped data.
 - 'Refresh Data' – For each section, this includes latest survey (condition) data from within the date range specified for SCANNER analysis.

'SCANNER Index' - (Module 4010) This calculates a SCANNER Condition Index using rules defined in a Weighting Set (Access database). There are two kinds of Weighting Set; Bin Identifier based and Probability based.

'Time Windows' - (Module 2020) This makes a copy of the Observation data for each of the Time Windows defined when data was loaded into the Analysis.

'Treatment Effects' - (Module 2210) For use with Create Strategies. Applies an Index Rule Set to the Observation data depending what (if any) Treatment is being carried out. E.g. to reduce roughness by a particular value or reset it to a particular value.

'Validate Unknowns' - (Module 4010) If observations on the same length have different feature groups these are put together into one.

'Whole Network Section' - (Module 0180) This takes all the observations present and aggregates them to the entire length of the Section. This results in chopped data.

Parameters: Parameters may be used to further define the action to be carried out by a particular Sub-Process like:

- The actual Rule Set for an Apply Index Rules Sub-Process.
- The actual length to use in a Fixed Length Sub-Process.

Save Data: Select from the drop down to tell Confirm how the analysed data is to be treated at the end of each Process Stage. The data remains available for the following process stage in a Process Type whether saved or not:

'No' - Data is not saved at the end of the Process Stage

'Observations' - All observation data is saved at the end of the Process Stage.

'All Data' - All the data is saved at the end of the Process Stage.

'Pause' - The Process is paused when it has completed this Stage.

'Stop' - The Process is stopped at when it has completed this Stage.

The 'Pause' and 'Stop' options allow the saved data set to be used to carry out processing from that point onwards in another Process Type or to be used in its own right for reporting or validation purposes. The data sets are saved in the condition surveys format.

Process Type - Params Button

The 'Params' button will bring up the Parameters screen. From here you can either select from a drop-down list for Rule Sets, or enter values for other Sub-Processes.

When the 'Enhanced Mode' setting is checked this merge method ensures consistent Defect Lengths across all condition indices. If left unchecked, the current processing remains unchanged.

Index Rule Set

Index Rule sets are where the rules used for calculation are held. These Index rules perform operations on the data sets. Each Index Rule Set may contain a number of rules and constants. The individual rules within the set perform some type of operation on the data and the result is stored under the observation type specified.

Under the Rules tab on the Index Rule Set screen clicking on the 'Detail' button will display the Index Rule screen. At this point new rules can be added to the rule set or existing rules can be modified. When modifying an existing rule this can be selected on the Rules Tab area of the Index

Rule Set screen before pressing the 'Detail' button. Alternatively, selection can be made using the 'Binoculars' button once the Index Rule screen has been activated.

This field will define how these results are combined to form the final result. This is the result that will then be stored as the observation defined by the Target Obs. Type field. Index Rule - Applicability Tab

The Applicability tab defines the types of feature group to which the rule is applied.

Selecting the Applicability tab on the Index Rule screen and pressing the Detail button will display a different Index Calculation screen with the field to set the Feature Group.

To add a new Feature Group click on the Clear/New button.

The rule will only be applied to features belonging to the groups specified.

Rule Name: This is automatically completed by the system with the name of the current rule being worked on.

Feature Group: Select from the drop down of defined Feature Groups as required.

Rule Set Formula Notes

Index Rule Calculations and Treatment Rule Lines are both constructed using a formula that is evaluated on each applicable length within the analysis.

The main difference between the two is that Index Rule Calculations evaluated to a numerical value which is then stored in a result Observation Type, whereas Treatment Rule Lines evaluate to a true or false and are used to determine whether a particular Treatment Rule Line is triggered for a length.

The main component of the formula is generally an Observation value indicated by OBS(OBSTYPE) where OBSTYPE is the Code of the specific Observation Type whose value will be substituted into the formula when it is evaluated, but other codes can be used as shown below.

Placeholder	Description
OBS(OBSTYPE)	The Observation value on the length for Observation Type with code OBSTYPE.
ATTR(ATTRTYPE)	The Attribute Value Code of the parent Feature for the ATTR-TYPE pick list Attribute Type.
CONST(CONSTCODE)	The value Rule Set Constant with Code CONSTCODE on this Rule Set.
OBSLEN	The length on which the rule is being evaluated (i.e. the difference between the Start and End Distance, usually in metres).
DAYSAGO(DATETYPE)	The number of days from the value of Feature Date DATETYPE on the parent Feature up to the present day, for example for a construction date Date Type this would allow the age of the asset to be used in a formula.

A number of simple illustrative examples are listed below.

The following Index Rule Calculation text could be used to combine together three specific surface condition Observations to produce a composite measure of the overall surface condition. In this case the first condition is considered the main indicator and is thus weighted more heavily.

The following Treatment Rule Line text could be used to test if a Cracking Observation, measured as a percentage area, exceeds a specified intervention level. The intervention level is here defined as a Rule Set Constant so that it can be referenced in several Rules.

Rule Set Flowchart

When working through index rule sets, Confirm proceeds as follows:

1. Take first Rule
2. Within each Rule, there will be one or more calculations. Work through these calculations in priority order.
3. For each calculation, carry out the calculation specified (if applicable to the feature), and then feed the result into the transformation curve specified (if any). Take the result from the transformation curve and remember it.
4. Repeat step 3 above until all calculations in the rule have been completed.
5. Based on the combination type specified for the rule, either take the highest of, sum of or average of the results from all the calculations and store in the specified Target Observation Type.

Move to next rule, and repeat steps 2 to 6 until all rules have been completed.

Projection Rule Set - Action button

Each of the following options are used in connection with T3 processing.

Edit Effects of Treatment

This option is used to edit the effects that certain types of treatment have. E.g. doing a certain treatment adds 10 years to the life of a road or resets it's 'age' to 20 years.

Edit Carriageway Group After Treatment

This option is used to specify transformations that apply to the group when a treatment has been completed. E.g. Concrete after a Bituminous overlay now has a Bituminous surface type.

Edit Projection Relationship

This option is used to define which A, B, C and D values are to be used in projection calculations for each combination of varying attributes.

Treatment Rule Set

Treatment Rule Sets determine the type of treatment to be applied depending on an index value that has been previously calculated. The initial screen closely resembles the Index Rule Set screen, having entries for code, name, version, notes etc and also two tabs in the lower half for rules and constants. Constants are used to define values to be used within the treatment selection, allowing for easy changes should this be required.

A Treatment Rule set is similar to an Index Rule set in the way it is defined and therefore many of the input screens are almost identical in appearance and in the way data is entered.

- Dead:** Clicking on the checkbox marks the Treatment Rule set as unused or dead. It will no longer appear on drop downs, pick lists, etc. however, the details remain in the database.
- Name:** A 30 character description as appropriate for each Treatment Rule set.
- Notes:** A free form text description or other notes of virtually unlimited length.
- Carry Forward... :** Clicking on the checkbox determines whether a particular Rule Set retains the observations to which it is applied, adding a new set of results alongside the original. If not set the current data is discarded and a new Data Set is created for the results.
- Observations must have... :** This box should be checked if the input condition data must be chopped before processing is carried out.
- Note:** Where a Rule Set is carrying forward data, any calculation that results in an Observation of a type that already exists will overwrite the existing value with the new one.
- Note:** If rules are going to combine different types of observations together rather than simply

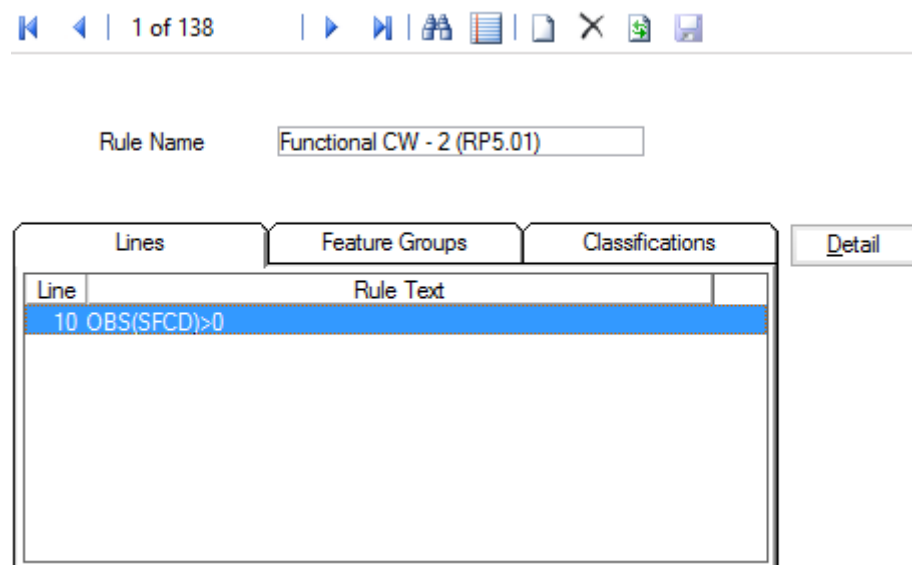
apply transformations to each one individually, data must be chopped to common lengths in order for the Rule Set to be applied.

Treatment Rule Sets - Rules Tab

The Rules tab lists the rules to be applied to determine treatments.

Pressing the 'Detail' button will display the Treatment Selection Rule screen.

For each length within each Feature in the Analysis, all applicable Treatment Rules (those which include both the Feature Group and Classification of the length) are checked in turn to see whether a Treatment is triggered.



Rule Name: A 30 character name/description as appropriate for each rule. This must be unique.

Treatment Selection Rule - Lines Tab

Each Treatment Rule consists of one or more Rule Lines. Each Rule Line is in the form of a logical operator or test rather than a calculation. The Lines tab window lists these Treatment Selection Rule Lines.

Selecting the desired rule and double clicking or pressing the Detail button displays the Treatment Selection Rule Line screen.

The SOR Group defines the treatment type. The ranking value is generated by applying the transformation specified on the Ranking Curve line to the observation type specified on the Observe Type line. The treatment will also have a priority. This is Mandatory for functional treatments and Desirable for the rest.

Treatment Selection Rule - Feature Groups Tab

The Feature Groups to which the Treatment Selection Rule applies are shown in the window associated with the Feature Groups Tab.

Selecting the desired rule and double clicking or pressing the 'Detail' button displays the Treatment Rule Feature Group screen.

For each rule, select the required Feature Group.

Treatment Selection Rule - Network Priorities Tab

The Network Priorities applicable to the Treatment Selection Rule are set here. Only the Network Priorities to which the Treatment Selection Rule applies should be entered here.

Selecting the desired rule and double clicking or pressing the 'Detail' button displays the Treatment Rule Network Priority screen.

For each rule, select the required Network Priority

Rule Set Formula Notes

Index Rule Calculations and Treatment Rule Lines are both constructed using a formula that is evaluated on each applicable length within the analysis.

The main difference between the two is that Index Rule Calculations evaluated to a numerical value which is then stored in a result Observation Type, whereas Treatment Rule Lines evaluate to a true or false and are used to determine whether a particular Treatment Rule Line is triggered for a length.

The main component of the formula is generally an Observation value indicated by OBS(OBSTYPE) where OBSTYPE is the Code of the specific Observation Type whose value will be substituted into the formula when it is evaluated, but other codes can be used as shown below.

Placeholder	Description
OBS(OBSTYPE)	The Observation value on the length for Observation Type with code OBSTYPE.
ATTR(ATTRTYPE)	The Attribute Value Code of the parent Feature for the ATTR-TYPE pick list Attribute Type.
CONST(CONSTCODE)	The value Rule Set Constant with Code CONSTCODE on this Rule Set.
OBSLEN	The length on which the rule is being evaluated (i.e. the difference between the Start and End Distance, usually in metres).
DAYSAGO(DATETYPE)	The number of days from the value of Feature Date DATETYPE on the parent Feature up to the present day, for example for a construction date Date Type this would allow the age of the asset to be used in a formula.

A number of simple illustrative examples are listed below.

The following Index Rule Calculation text could be used to combine together three specific surface condition Observations to produce a composite measure of the overall surface condition. In this case the first condition is considered the main indicator and is thus weighted more heavily.

$$0.6 * \text{OBS}(\text{SURF1}) + 0.2 * \text{OBS}(\text{SURF2}) + 0.2 * \text{OBS}(\text{SURF3})$$

The following Treatment Rule Line text could be used to test if a Cracking Observation, measured as a percentage area, exceeds a specified intervention level. The intervention level is here defined as a Rule Set Constant so that it can be referenced in several Rules.

$$\text{OBS}(\text{CAREA}) > \text{CONST}(\text{INTLEVEL})$$

The following two Treatment Rule Line text examples show how this could be extended to use an Attribute of the Feature to apply a different intervention level for Urban and Rural road assets.

$$\begin{aligned} &\text{ATTR}(\text{URBN}) = \text{"U"} \text{ AND } \text{OBS}(\text{CAREA}) \geq \text{CONST}(\text{INTLEVEL1}) \\ &\text{ATTR}(\text{URBN}) = \text{"R"} \text{ AND } \text{OBS}(\text{CAREA}) \geq \text{CONST}(\text{INTLEVEL2}) \end{aligned}$$


Treatment Rule Set - Constants Tab

Selecting the Constants tab will show a list of the constants set up for the particular treatment rule set.

Treatment Rule Set constants can be defined and can then be used in all rules within that Rule Set. These can be used as threshold values for tests in the Treatment Selection Rules. The Constants are then used in the Treatment Rule Line tests.

In the case of the predefined rules, there are a large number of constants, defining such things as intervention levels (IL in the name).

Pressing the 'Detail' button will display the Rule Set Constant screen.

- Code: A unique code of up to 8 alpha/numeric characters.

Transformation Curve

Transformation Curves are used to transform results from treatment or Index Rules. The curve is basically an X-Y graph, the X being the result passed from the rule, the Y being the returned value.


Transformation Curves can be applied to data for several reasons. An S-shaped curve might be used to reduce the effect of extreme values on calculations, or alternatively a curve could be defined to exaggerate such effects if this is desirable.

In the UKPMS use of Confirm, curves are defined to model rating lookup tables so that all observed values, however recorded, are converted to a value between 0 and 100, so that all can be compared equally. It is also possible to define Transformation Curves to approximate mathematical functions.

Description: A free text description of the Transformation Curve.

The lower part of the screen displays a graph on the left and a series of data points on the right. The points are edited by typing in new numbers.

New / Clear: Used to add extra points. Select an existing point, then click on the New/Clear button, a new entry is then inserted above the current point. The defined points are shown on the graph as small red tick marks.

Delete: Use this to delete a point. Select the point and click on the 'Delete' button.

Note: Do not click on the larger Delete button, this will delete the entire Transformation Curve.

SOR Group

The SOR Group provides a short cut for producing standard Jobs by providing all the necessary SORs as a Group.

Groups can be used when creating Jobs - from the Jobs form, from Defects (Condition Survey) and from Enquiries (Customer Services).

An SOR (Schedule of Rates) Item is the unit of work. The SOR Item will usually be defined in the Contract as the items of work the Contractor has bid on.

SOR Items need not necessarily be priced, or included in Contract. Within Confirm the function of an SOR is to provide an instruction for work of a particular kind to be carried out.

All the SOR Items are defined in the SOR Item library. Their function, and the way they will interact with the system, is also defined within the SOR Item library.

SOR Item Code: Up to eight alphanumeric characters

Description: Up to 55 characters

Full Description: An optional free text field. The full description may be optionally displayed on Works Orders, Work Tickets and reports

Schedule: Select the Schedule from the drop down list. The drop down list references the **Schedule lookup**.

Price Per: Enter a number in the first field (other than zero). Select a Unit of Measure from the drop down of the second field. The drop down list references the **Unit of Measure Lookup**.

Estimated Quantity: (Optional)

Entering an Estimated Quantity (i.e. Unit of Measure per year) will provide that information on the Contract Bill of Quantities. It is unnecessary to enter an estimated quantity for programmed work since this can be derived by the system from Maintenance Regimes.

Note: An Estimated Quantity for Non Routine work can be calculated by running the Quantity Calc utility in the SOR Item Lookups. This will derive a quantity based on Non-routine work orders in the system for a past period.

- Target Rate:** (Optional)
- Entering a Target rate will provide information for reports on the estimated cost of Routine Work, based on Target Rate, and for costing non-Routine Jobs, based on Target Rate.
- This must be populated for Confirm to correctly to estimate Treatment Costs for UKPMS purposes.
- Specification Ref:** An optional free text field for the entry of the specification reference
- SOR Type:** Select from the drop down:
- None: for any item other than the 'Liquidated Damages' Item and the 'Retention' Item
- Liquidated Damages: for the Liquidated Damages Item. Where Liquidated Damages will be calculated against Non Routine Work. In order to provided the tool for applying a value to the Liquidated damages, one SOR Item is created, measured 'per Pound (£), and identified as a 'Liquidated Damages' Item.
- Retention item: for the Retention Item. Where part of the value of Non Routine Work will be retained for a guarantee period. In order to provided the tool for applying a value to the retention, one SOR Item is created, measured 'per Pound (£), and identified as the 'Retention' Item
- Percentage Item: See 'To create Percentage Items' below.
- Annual Performance:** (Applicable to the Contract Management module)
- Check this box to identify the Item as an 'Annual Performance' Item. Annual Performance Items represent a yearly cost for an item of work (so that 'per 100 Sq. metres' is read as 'per 100 square metres per year'), which will be paid for (under the Contract Management module) in equal instalments over a year.
- Non-Payment:** (Applicable to the Contract Management module)
- Check this to identify items that will be included on Routine Maintenance Works Orders but will not be paid for. This might be inspection items, which need to be programmed but for which the Contractor is not paid. Alternatively, there might be a need for instructive items where an Annual Performance Item is being used to make the payments.
- Note:** These are not intended for use with Non-Routine Works.
- Contingency:** (Applicable to the Contract Management module)
- Check this to allow this SOR item to be 'hidden' on a Works order. There is usually only one Contingency item - priced per Pound (£), which is used to build extra value into a non-routine works order. The extra value can be hidden on the Order, but registers in committal and budget reports.
- Exclude Job:** Check this to exclude Jobs carrying this SOR from being automatically batched onto Orders on upload from the mobile device.

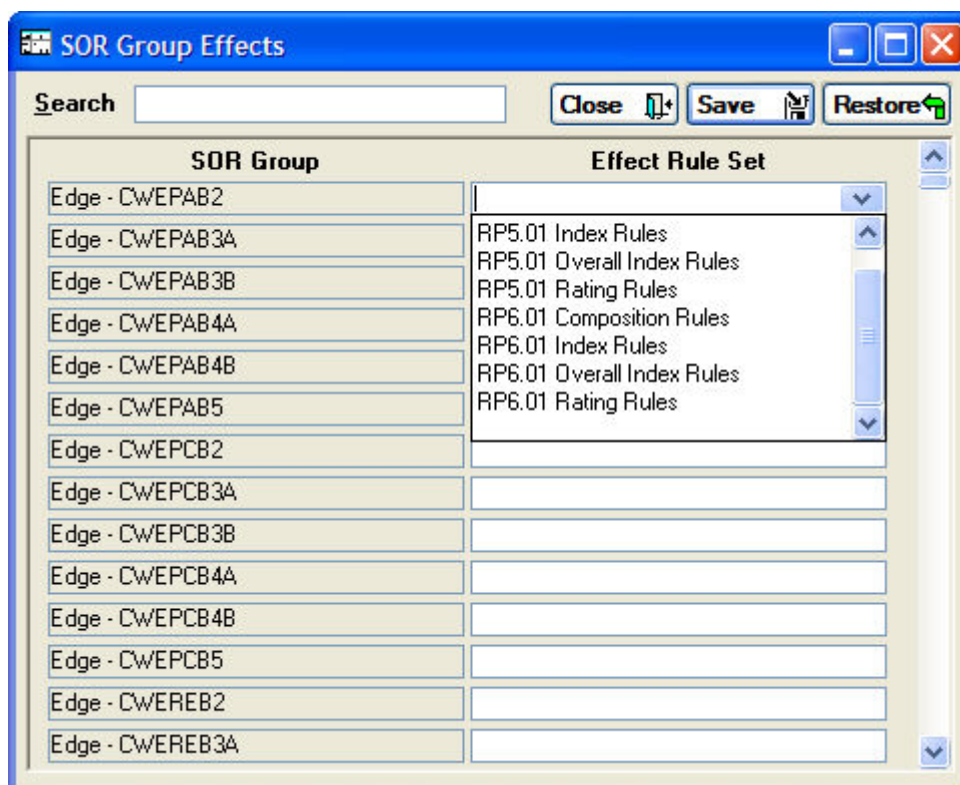
SOR Quantity From: Enter the lower limit of the band. The Ordered Quantity must be 'more than or equal to' this quantity to use this band.

SOR Quantity To: Enter the upper limit of the band. The Ordered Quantity must be 'less than' this quantity to use this band.

SOR Group Effects

The SOR Group Effects screen displays all of the SOR groups. This screen is then used to link an Index Rule Set to each group which then determines how the Treatment Effects process will behave.

Note: This is not used for T2 or T3 UKPMS processing.



Budget Instance

The Budget Instance screen is used to define different Budget scenarios to be used in the allocation of funds to suggested treatments. Entries made in the Budget Instance form do not appear in other parts of Confirm and are not counted as actual income/expenditure.

When running a **Survey Treatment Summary** on page 23, you will be asked for a Budget Instance against which to allocate costs.

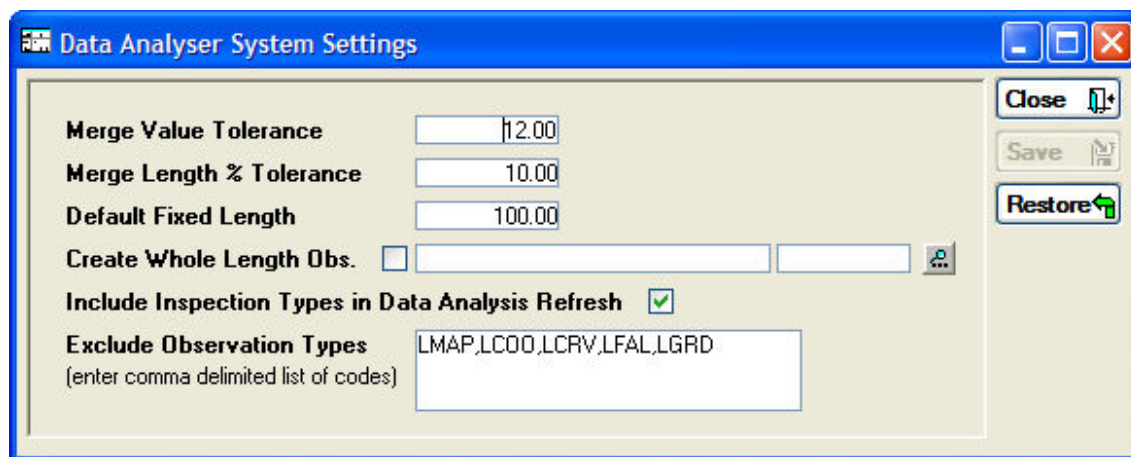
The Priority library provides the means of linking Status, Price Factor and Follow Up to create the starting point, and proposed duration, for a Job. One Priority is set as the default, providing a new Job with a Price Factor, and its first Status. An estimated completion for the Job may also be calculated based on the Follow Up entered in the 'Completion' field (if the Contract Management System Settings allow it).

Priority Code	Up to four alphanumeric characters.
Dead	If a Priority is flagged as dead, this will prevent this Priority from being selected interactively by a user creating or updating a Job (or Defect).
Name	Up to 30 characters.
Notes	Free text to supply more information about this Priority.
Status	Enter (or select from the pick list) the status for this Priority. The pick list references the Status Lookup.
Price Factor	Select the Price Factor for this Priority. The drop down list references the Price Factor lookup.
Completion	Select a time-scale. The drop down references the Follow Up lookup. Note: When raising Street Works Notices from Jobs, Confirm does NOT count the current day in the duration calculation for the Work Type. The Completion Follow Up should therefore be set one day shorter than normally required. E.g. a Minor Works is normally 3 Working Days which therefore requires a 2 Working Day Follow up.
Device Creation of Orders	Select from: 'Do Not Create' - do not create an Order for Jobs with this Priority. 'Group but do not Commit' - group the Jobs with this Priority onto an Order but do not commit the Order. 'Group and Commit' - group the Jobs with this Priority onto an Order and commit. 'Do not group and do not commit' - each Job with this Priority will be placed on it's own uncommitted Order. 'Do not group but commit' - each Job with this Priority will be placed on it's own committed Order.
Device and Web Data Key	Optionally specify a Data Key to restrict which Users will have this lookup available on a mobile device or via Confirm on the web. Note: For mobile devices, this lookup will still be transferred, it will simply be hidden from the User when logged in.

Urgency	(Street Works Initiation module) This field can be used to automatically trigger the creation of Street Works Notices from Jobs. Refer to the Street Works Initiation from Jobs help section for more information.
Raise a Defect Job	(Condition Survey module) This is checked by default for a new record, and will set the 'Raise Job' flag on the Defect automatically when this Priority is selected for the Defect. Uncheck this for Priorities in which a Job will not be automatically raised from the Defect. This setting is also used when uploading Defects from a device to tell Confirm if a Job should be raised. Note: Confirm will ignore this setting if a Contract, Cost Code or Items are supplied with a Defect imported from a device. A Job will be raised so that this information is not lost.
Ranking Order	(PMS Treatment Selection - Automatic module) Enter a ranking which will be used to when running the Budget Optimisation Report. Confirm will allocate available funds to all priority 1 treatments before it proceeds to look at priority 2 and so on.
Nominal Value	(Applicable for Defect Priority Calculation in ConfirmConnect® only) This field indicates the numeric value for a defect priority. This should be greater than or equal to its Minimum and less than its Maximum. Valid Range: 0.01 till 9999999.99 (both values inclusive). Note: Nominal Value is required for Defect Default Priority. If not populated than Default Priority won't be adjusted automatically.
Minimum/Maximum	(Applicable for Defect Priority Calculation in ConfirmConnect® only) These fields specifies the range of a defect priority. Maximum is un-editable and is derived from the minimum of next priority if available. Valid Range: 0.01 till 9999999.99 (both values inclusive).

Data Analyser System Settings

This screen is used to pre-set the default values to be used for Data Analysis.



Merge Value Tolerance: The default Value for the Merge process tolerance is set here. This can be overridden in the Process Type with the Merge process selected.

Merge Length % Tolerance: The default Length Percent for the Merge process tolerance is set here. This can be overridden in the Process Type with the Merge process selected.

Default Fixed Length: The Default Fixed length for the Fixed Length process is set here. This can be overridden in the Process Type with the Fixed Length process selected.

Create Whole Length Obs.: This setting is used by the Refresh Data filter to set the 'Create whole length observations' check box. An appropriate Observation Type should also be specified.

Confirm will create Whole Length Observations of this Type for all Features being analysed. This ensures that rules will be executed even if no condition data is present.

If a Feature has no other data, then a single observation is created on the default XSP for the Feature's Feature Group. If real data does exist, then a Whole Length Observation will be created for every XSP/Group combination where data exists.

Confirm does not keep these Observations once they are created. Where it is required to carry the Observations forward through processing this must be coded up in the rules/processes as for other Observations.

Note: Add Data From Analysis' does not have the option to create Whole Length Observations.

Include Inspection Types... : Tick this to include Inspection Types in the Data Analysis Refresh option.

Exclude Observation Types: Supply a comma delimited list of Observation Type codes that should be excluded during the Refresh Data stage of the Data Analysis.

Note: Care should be taken to not exclude data that would affect the results of the Analysis.

Econometric System Settings

These settings are used with the Economic optimisation module (2210).

Contract for Cost- ing: Specify a Contract to be used for estimating Treatment costs.

Price Factor (Financial):	Used with the Contract above to estimate the financial cost of a Treatment.
Price Factor (Economic):	Used with the Contract above to estimate the financial cost of a Treatment.
Do Nothing SOR Group:	Used by "Create Strategies" when creating a "Do Nothing" Treatment, and to determine which Treatments (those other than "Do Nothing") require a new Strategy to be created
Do Nothing Priority:	Used by "Create Strategies" when creating a "Do Nothing" Treatment.
Rehabilitation years:	Used by "Create Strategies" to determine how many Strategies to create for a Treatment, e.g. if Rehabilitation Years is set to 3 it will create one Strategy for carrying out the Treatment at the current date, one for the following year, and one for the year after that.
Treatment Cost Obs. Type:	If this is set then the "Treatment Effects" Sub-Process will create an Observation of this Type and store the Treatment Cost in it.
Economic Cost Obs. Type:	Used by "Calculate Benefit", which looks at the value of an Observation of this type to get the Economic Cost of a particular Treatment. If not set, it will just take the Financial Cost to be the Economic Cost.
Economic Ind. Obs. Type:	Used by "Calculate Benefit", which looks at the value of an Observation of this type to get the Benefit of a particular Treatment.
Economic Indicator Type:	To specify if the Economic Indicator specified above is a cost rather than a benefit, in which case its value will be reversed.

Network Analysis Data Export Settings

These settings are used to specify the format that will be used when the HDM4 data is exported via the Network Analysis Data Export report. A driver must be specified to create a .dbf file when the report is run.

For further details on how to set these fields please refer to your HDM4 documentation.

Bear in mind that each Work Group must have a unique range of numbers, but if you issue one range to start with, which proves to be too few numbers, you can later come back and use the second range. You can also amend the 'Maximum' number to make room for a range of numbers for a new Work Groups.

The total range of numbers is from 1 to 99999999. These numbers need to be distributed amongst the Work Groups working with the Data Analyser.
