# **Maintenance Management**

The Maintenance Management folder contains the utilities and screens to perform maintenance actions to Assets. These actions can be adhoc (non Routine), part of Cyclic Regimes or annual Routine Maintenance.

## Job

A Job will define an item of Non-Routine or Cyclic work.

It will:

- · define the Site and Plot where the work is to be carried out,
- give related details such a Cost Code and Customer,
- establish a time-scale for the work to be carried out,
- have a life cycle determined in stages or Statuses,
- be made up of one or more SOR items detailing the work.

It may also be assigned to a 'Preferred Contract', thus derive an Estimated Value from the Contract prices. However, a Job need not be raised under any particular Contract.

A Job can be reported on, in various ways. Batch tools are available to produce numbers of Jobs at once, to advance the Status of Jobs, and to archive Jobs

In order to commit a Job, it must be put onto a Non Routine Works Order, under a particular Contract.

#### Job

The Job form carries information on a series of tabs. The Job tab is uppermost when the form is first displayed.

The Job tab carries the specific details for the Job - the Site, Plot Number and details of the work and location for the Job.

Job Number: When creating a new Job, leave this field blank so that Confirm can assign the next available number, from the Work Group Seed numbers when it is saved.

Job Seed numbers are set in the Job Seed Number Lookup.

#### Asset Maintenance\Maintenance Lookups

To select an existing Job, enter the Job Number then tab out of the field.

- Placed on W.O.: The first part of this field will remain blank until the Job is placed on a Works Order and Committed. Once the Order is Committed the second part of the field will change to 'Committed'.
- Parent Job: (0970 CM Works Precedence)

The Parent Job field allows a hierarchy of Jobs to be created where many individual Jobs may be logged beneath a single over-arching Job.

To assign a Parent (over-arching) Job, simply enter the Parent Job's reference in this field, or use the Pick button to filter Jobs to find the appropriate Parent. A Parent Job may also have a Parent, hence any particular hierarchy of Jobs may be created.

A Parent Job reference will be rejected if the Job Number does not exist or if the Current Job is already a Parent within the requested Parent's hierarchy - in other words you cannot create a circular chain of Parent Jobs. If a circular chain is detected then an error similar to the following will be displayed:



To remove a Job's Parent, clear the Parent Job field and save the record.

The **Child Jobs tab** on page 17 lists any Jobs whose Parent is the currently selected Job.

Site: Type in a Site name or Code, or use the pick button to select a Site from the Site Register.

#### Site Register

Locality, Town and County will be displayed for the selected Site and cannot be edited.

Feature Id: Optionally enter a Feature Id to pick the Feature for this Job or use the pick button to select a Feature on the entered Site.

Plot Number: Type in a Plot number to select a Feature. If a Feature was selected using the pick button on the Feature Id field, this will already be populated.

- Location: The text entered in the Location field of the Feature will be automatically entered here and is not editable.
- Area: The Area assigned to the current Feature will be displayed, this cannot be edited.

Ward: The Ward assigned to the current Feature will be displayed, this cannot be edited. Description: A free text field into which any explanation of the work can be entered. (Optional) **Note:** Jobs can be prevented from Committal if the Description is blank by ticking the Job System Setting 'Prevent Committal of Jobs with No Description' Asset Maintenance\Maintenance Lookups Work Location: A free text field into which any location details can be entered. (Optional) **Note:** Jobs raised on the 'Whole Site Feature Type' can be prevented from Committal if the Work Location is blank by ticking the Job System Setting 'Prevent Committal of Jobs on Whole Site Feature with No Location' Asset Maintenance\Maintenance Lookups Job Type: This field will default to the Job Type specified in the Job System Settings when the screen is opened and a new Job is being entered. Asset Maintenance\Maintenance Lookups This can be changed if not applicable for the current Job. The pick list references the Job Type lookup. Asset Maintenance\Maintenance Lookups This field may have been set to a different default depending on where it was created from e.g. Enquiry Subject Job, Defect Type, Work Type or Maintenance Regime. Estimated Value: The Estimated Value will derive from the Target Rate entered in the SOR Item library (if one is entered) or if Preferred Contract is entered, from the Contract Rates. If no Target Rates are present, and no Preferred Contract is entered, the Estimated Value will be blank Hazard Type: This field will default to the Hazard Type associated with the Job Type specified in the Job System Settings when the screen is opened and a new Job is being entered. Changing the Job Type will set the Hazard Type to the appropriate default value. The Hazard Type can also be changed directly if not applicable for the current Job. Priority: This field will default from the Priority set in the General System Settings. System Administration\Security The default can be changed if a different Priority is required for the Job being entered. Use the drop down list to alter the Priority. Asset Maintenance\Maintenance Lookups Price Factor: The default Price Factor may be derived in one of two ways: Where a Price Factor Matrix is in place, the default will derive from the combination of the Feature Smart Value, and the Job Priority. The Price Factor Matrix is created for the Feature Group.

#### Asset Register\Feature Lookups

Where no Price Factor Matrix has been set up, the default will be set by the Priority.

#### Asset Maintenance\Maintenance Lookups

Use the drop down list to alter the Price Factor if necessary.

Asset Maintenance\Maintenance Lookups

Cost Code: Select a Cost Code which will be used as a default for new Job Items. Leave this blank if the Job Item SOR is to be derived from the Feature or overriding Cost Code.

#### Asset Register\Feature

The Cost Code pick list references the Cost Code Lookup.

Site Register\Site Lookups\Operational Lookups

Partial Payment: Check this to tell Confirm that Partial Payment can be made for this Job.

Setting Partial Payment on the Job will not set the 'Completed' flag (on the Payment Job in the Payment Batch) until the full value of the work has been paid. The Job can therefore be placed on several Payment Batches - each to pay off partial cost of the work.

**Note:** The 'Complete' flag on the Payment Job can be altered at the payment stage - see "**Payment Processing - Payment Job**"

Customer: This field will default to the Customer for the Feature that has been selected. Use the drop down list to alter this if necessary.

**Note:** This field is also seen on the Additional tab, and is editable on either tab.

- Cust Ref: An optional free text field into which a reference can be entered. This can be used as a grouping mechanism to later report on a series of Jobs which all carry the same reference.
- Pref Contr: Optionally enter a Contract which will apply an 'Estimated Value' to the Job, and replace any value applied from the SOR Item Target Rate. When the Job is Committed, the Preferred Contract field will be updated to match the Contract that the Order was Committed for.

#### Asset Maintenance\SOR Item

**Note:** This field is also seen on the Additional tab, and is editable on either tab.

Status: When Jobs are progressed, the Status is updated. The first Status a Job acquires defaults from the selected Priority, and is editable. Subsequent Statuses may be set by the system because of certain actions carried out (Committal for instance), by a Batch Status update, or by manually altering the Status for this single Job.

**Note:** This field is also seen on the Current Status tab, and is editable on either tab.

Officer: Enter an Action Officer who will be responsible for the progress of the Job. The Action Officer linked with the User who is currently logged in will be entered by default. The Officer may be edited. **Note:** This field is also seen on the Current Status tab, and is editable on either tab.

#### Job Dates

Please refer to the Additional tab for details on these dates.

#### Additional tab

Click on the Additional tab to display the Additional details portion of the form:

- Job Number: Will be copied from the Job tab Customer: The default Customer for the Feature will already be entered here. Use the Drop-down list to alter this if necessary. Note: This field is also seen on the Job tab, and is editable on either tab. Pref. Contract: Entering a Contract Code will apply an Estimated Value to the Job, and supersede a value applied from SOR Item target rate. (Optional) **Note:** This field is also seen on the Job tab, and is editable on either tab. This is derived from the Contract Area for the selected Feature. It cannot be Contract Area: altered. **Note:** The Contract Area for the Feature may not be covered by the Contract you have entered as the Preferred Contract. This will not prevent the Job displaying an Estimated Value, but it will prevent the Job from coming onto an Order for this Contact Traffic Manage-This field will default from the Job Type 'Default Traffic Management' setting ment: but can be changed for this Job. This drop down references the Traffic Management lookup. Street Works\Street Works Lookups Workstream: The Workstream field allows Jobs to be placed onto a Workstream, which can be used for the grouping of Jobs when scheduling in ConfirmWorkzone. Job Dates
- Entered: The date on which this Job was raised. Entered automatically as today's date but can be amended
   Est. Start Date: You may enter an Estimated Start Date here from which the Estimated Completion will be calculated in preference to the Entered Date. Using this field will ensure that the Estimated Completion date accurately reflects the date on which the work was started rather than the date on which the Job was entered into Confirm.
   Note: This field is also seen on the Job tab, and is editable on either tab.
   Actual Start Date: Enter the date to record when the Job actually started. This will be automatically set if a Job Status is selected with the 'In Progress' setting ticked.

   Est. Completion: Estimated Completion is automatically calculated in three different ways:

Actual Comple- tion:	Will be entered automatically by the system as the date on which the Job achieves a Status that has the 'Complete' flag set. Statuses are set up in the Status library.

Liability Date:	A Liability date will be calculated from the Actual Completion date (when one is entered for this Job), based on the Liability follow up set against the Price Factor for the Contract, if one is set.

#### Geography

Easting, Northing Optional fields giving a geographical reference for the location of the work. & Altitude: These values will be used to plot the location of the Job on a map when linked with the mapping module.

#### **External System**

Name, Order Ref-Optional fields giving details of a Jobs Order and Job reference within another erence & Job Reference within another external system. The name of that external system is also displayed. erence: Note: These fields are only displayed if Module 1620 (Contractor Access Agent) is enabled.

#### **Current Status tab**

Click on the Current Status tab to display the Current Status portion of the form:

**Note:** This tab has all the compulsory fields completed from defaults. It is not therefore necessary to access it unless you want to change the defaults.

The Current Status tab gives details of the current stage of the Job. The stages a Job may pass through are defined as Statuses.

#### Asset Management\Maintenance Lookups

Each Status is assigned a log number, is logged by a user, and assigned to an Action Officer.

Job Number:	Copied from the Job Tab
Log Number:	A consecutive number will be assigned by Confirm to each status given to this Job.
Logged:	The date and time this Status is logged. This is set when the new status is entered and cannot be altered.
Logged by:	The User logging the Status. This is automatically entered from User inform- ation and cannot be altered.
Description:	Text notes on the current status or change of status. (Optional)
Status:	The first Status a Job acquires defaults from Priority, and is editable. Sub- sequent Statuses may be set by the system because of certain actions carried out (committal for instance), by a Batch Status update, or by manually altering the status for this single Job.
	Note: This field is also seen on the Job tab, and is editable on either tab.
Officer:	The Action Officer responsible for the progress of the Job. The Action Officer linked with the User who is currently logged in will be entered by default. The Officer may be edited
	Note: This field is also seen on the Job tab, and is editable on either tab.

Confirm

- Effective Date: Today's date is entered by default and can be altered. Effective date provides the basis for the follow up date
- Follow Up: Default, derived from the Follow up set for the Status in the Status library, is already entered. Use the Drop-down list to alter this if necessary.
- Follow Up Date: A date calculated on the Follow Up specified above, and the effective date as set in the Effective date field.
- Original Value: This is the sum of the Original Values found on the Order Item screen for the Order Job.
- Variation Value: This is the sum of the difference between the New Value and the Old Value for all committed Variation Items on the Job.
- Current Value: This is the sum of the Current Values found on the Order Item screen for the Order Job.
- Paid to Date: This is the sum of all committed Payment Items for the Job.
- Requested Value: This is the sum of all uncommitted Payment Request Items for the Job. Any cancelled uncommitted Payment Requests are not included. Cancelled Payment Requests are those which are at a Request Status of 'Closed' but not 'Authorised'.

**Note:** These values are calculated by Confirm when a Job is selected and are not actual columns in the database. Exporting the data from the Job screen will not export these values.

#### SOR Item tab

The SOR Item tab displays the Job Item form, which is used to enter the SOR(s) that will make up this Job.

Click on the SOR Items tab, and then on the Detail button to access the Job Item form:

Job Number: Copied from the Job tab

- Item Number: Items added to a Job are automatically numbered from 10, in increments of 10. These numbers can be overwritten.
- SOR Item: Enter an SOR code or use the pick button. The pick list references the SOR Item library. The SOR Items available for selection are restricted by the Contractor and Price Factor specified on Job.

#### Asset Maintenance\SOR Item

- Full Description: The SOR Item full description will be entered here, copied from the SOR Item library.
- Rogue Description: Only available when a 'rogue' SOR Item is entered above. A 'rogue' SOR is one that uses a Unit of Measure that does not have the Rate Uplift flag checked. This is usually an Item worth a Pound (£) referencing Pound (£) as the Unit of Measure.

When the appropriate SOR is entered, the Rogue Description box becomes available and a description of the work can (optionally) be entered. See also "**Rogue button** on page 16"

Measurement: The drop down lists all Measurement Types that are referenced by the same Unit of Measure as the selected SOR.

To enter the Feature quantity in the Quantity field: - select the Measurement Type the Feature uses. This will automatically enter the Feature measurement into the Quantity field below.

To allow a free entry in the Quantity field: - leave the Measurement field blank

**Note:** The Measurement field is only appropriate for Measurement Types used by the Feature. If you select an SOR measured by the Hour, for instance, there is unlikely to be an appropriate Measurement Type recorded against the Feature (one using Hours as the Unit of Measure), and the Quantity field will become unavailable, with Zero quantity entered.

Unit Of Measure: Displays the 'Price Per' quantity and Unit of Measure as recorded in the SOR Item library

#### Asset Maintenance\SOR Item

Length, Width, Only available for Units of Measure flagged as being measured in this way in the Unit of Measure lookup.

#### Asset Register\Feature Lookups

If the fields are available, they must be used to enter the required quantity.

- Quantity: Is unavailable if:
  - The quantity is made up of Length, Width or Depth.
  - An entry has been made in the Measurement field above.

If the field is available, enter the required quantity referencing the Unit of Measure displayed in the Unit of Measure field above.

Cost Code: Default - from the Job (which in turn, if nothing was entered, will be defaulting from the overriding Cost Code, or the Feature).

The ability to set different Cost Codes on Job Items can be specifically disallowed by setting the Cost Code Protection settings on the Job System Settings screen.

#### Rogue button

**Note:** The Rogue Item field on the Job Item form can be directly completed without reference to this form.

#### Group button

The Group button allows you to use a Group of SORs without having to add each SOR separately to the Job.

Only the SOR Groups with atleast one SOR Item included in the BOQ of Contractor and Price Factor can be selected. To use a Group, enter (or select from the pick list) the SOR Group code. A quantity may be entered, which will be applied to all the SORs in the Group. Leave the Quantity field blank to return to the Job Item form and add quantities individually to each Item.

SOR Groups are created and stored in the SOR Group Lookup.

#### Asset Maintenance\SOR Item lookups

Click Ok to add the items in the selected Group to the Job.

#### Status Log tab

The Status Log tab displays all the Statuses the Job has held, with details of date and Action Officer.

The list may be viewed on the Status tab, with the current Status at the top and the others listed in reverse date order underneath.

The log may be viewed in more detail by clicking on the Detail button.

Each Status is held as a separate record and gives the date, the user who was logged in, any notes made at the time, the Action Officer, the Follow Up, and the date generated from the Follow Up.

#### Child Jobs tab

(0970 - CM Works Precedence)

The Child Jobs tab lists all the Jobs that are 'children' of the current Job record.

The Child Jobs can be opened by double-clicking on the record or using the Detail button with a Child Job selected.

Using the 'Batch' button will allow you to assign multiple Jobs as children of the currently selected Job record. Clicking the 'Batch' button allows you to filter for existing Jobs, when the filter has been submitted and the preview saved the Parent/Child associations will be applied. The batch process can only be used to add Child Jobs and is not designed to remove associations. The 'Batch' button will not be available if the current Job record is an Archived Job.

#### Buttons

#### Order button

For Committed Jobs, the Order button displays the Job Order with the details of the Order which contains the Job.

#### Gang Allocation

(Works Management module)

Displays the Gang Allocation filter for allocating this Job to a Gang.

Enter the required Gang in the Gang field or select from the pick list. The pick list references the **Works Management\Gang** Lookup.

The Hours Required will derive from SMVs, entered in the **Works Management\Cost Detail** library, for the SORs used in this Job.

The Graph button will display the Gang Allocation graph.

See the Works Management manual for details on setting up and using Gangs.

**Note:** If the Job is not already on a Works Order, one will be created and committed using the Preferred Contract on the Job and the Default Order Header Work Type specified in Contract Management System Settings.

Information on how allocation data is stored can be found here: **Storing of Job Allocation Inform**ation. This information can be used when writing reports on current and historical Job allocations.

#### Precedence

(Works Precedence module)

This screen allows the order in which Jobs should be carried out to be set. The Job Precedence List shows a list of the Jobs in the order determined by Job Precedence. Setting precedence will also cause a warning to be issued when Jobs with a lower precedence are included on a Works Order before Jobs with higher precedence.

The Job details at the top of the screen reflect the job that is currently displayed in the underlying Job screen and cannot be edited. The direct link to the underlying Job screen means navigating between records on the Job Precedence screen causes the currently displayed Job on the Job screen to also change.

The central portion of the screen shows the Preceding Jobs that should be completed before the current job, and the bottom Succeeding Jobs which should not be started until the current job is complete.

#### Adding and deleting Jobs

Jobs are added by entering (or selecting from the pick list) a Job number into the Job No field. Click on Update to save the record changes.

Click on New to move down to a new line to enter another Job.

Click on Delete to remove the currently highlighted Job from the list.

#### Identifying other precedences

The Jobs listed in the Preceding and Succeeding areas show the following Job information: Job No, Description, Estimated and Actual Completion and Current Status. The far right 'Link' column shows whether the Job already has a Precedence set, if 'No' is shown then that Job is not linked to any other Precedence and if 'Yes' then this Job has its own set of Precedences.

To see the Precedence details for any of the Jobs in the lists double click on that row. This will cause another instance of the Job Precedence screen to be displayed for the selected Job but it will not be possible to add or remove Jobs from here, this can only be done from the screen that was opened directly from the Job.

#### Fast Variation

Variations are created to alter details of Committed work.

The Fast Variation screen enables the user to:

- View the current Variations associated with a Job.
- Edit a Works Target Completion Date and also vary Order Items.
- Create new Variations with the New button on the toolbar.
- Commit an uncommitted Variation.

The list at the bottom of the screen shows the Variation Order Items. Existing items can be edited by double-clicking or by selecting and clicking the Detail button. To add a new item click the Detail button and select the New item button on the Variation Item screen.

Click the 'Commit' button to commit the currently highlighted uncommitted Variation. Click the 'Cancel' button to exit, discarding all unsaved changes. Click the 'Save' button to save changes to the currently selected Variation.

#### Notice button

(Street Works Initiation - 3420)

This button is used with the Initiating Street Works Notices from Jobs functionality. Refer to the **Street Works Initiation from Jobs** help section for more information.

#### **Risks button**

Saving a Job directly in Confirm with a Feature or Inventory Item selected carrying an Attribute value flagged for 'Risk Warning' will display the Risk Assessment screen.

The Risk Assessment screen can be opened at any time by selecting the 'Risks' button. Each time the 'Risks' button is selected Confirm will check the Attribute lookups to see if there are any additional assessments to display. This will be done until the Job is 'Archived'. If any 'Risk Warnings' are no longer applicable (removed from the Attribute Values) these will not be removed from the Risk Assessments for this Job.

Assessments will only be removed (after warning the User) if the Feature is changed.

Each 'Risk Warning' applicable to the selected Feature or Inventory Item will be listed allowing the User to specify if the warning is applicable for the Job being carried out i.e. The Feature contains a certain Risk but the Job being carried out would not be affecting it.

The presence of Risks will not prevent an Order from being Committed.

Risk Assessments can be printed using the 'Risk Assessments' list option from the Job or Defect screens.

The Risk Assessments screen carries its own User Security option so individual Users can be prevented from Updating assessments.

#### Attrib button

Risk Warning.

(Module 0715 - Job Attributes)

Clicking on the 'Attrib' button displays the Job Attribute screen. Here any Operational Attributes that have been assigned to the selected Job are displayed.

Click Add to display the filter list for selection of the required Attribute. The Attribute will be added to Job Attribute form, with the default value.

Previously added Attributes may be removed (excluding attributes linked with the Job's Hazard Type) by selecting the Attribute and clicking on the 'Remove' button.

#### **Attributes Inherited from Defects**

If the Job was raised from a Defect, the will be inherited and placed on the Job.

Updates to the Defect's Attributes will be reflected on the Job's Attributes.

Removing an inherited Defect Attribute from the Job will not remove it from the Defect.

#### Attributes Inherited from Hazard Awareness

(Module 2310 - Hazard Awareness)

A Job will inherit Attributes from its Hazard Type.

If the Job's Hazard Type is changed, Attributes entered are retained if they are applicable to the new Hazard Type, or if they have been changed from their default value.

Some Attributes may be flagged as 'Must Change Default' on the Operational Attribute Types screen. This has no effect on the creation and editing of Jobs but it is not possible to Commit a Works Order while any of its Jobs have such Attributes still set to the Default Value.

#### **Commit button**

The Commit button allows uncommitted Jobs to be committed directly from the Job screen. It will put Job on to an Order and open Works Order Commit - Preview screen.

Access to this button is controlled via a 'Commit Button on Job' Security Option.

**Note:** For the new Order, the Work Type will be defaulted from 'Default Order Header Work Type" specified on the the Contract Management System Settings screen.

#### Priced Job Reports

#### **Priced Job List**

The Priced Job List shows the selected Jobs as a list, with the Jobs displayed in rows. The Job values based either on the Preferred Contract (where one is entered for the Job), or by the selection of a Contract in the Priced Job Sheet filter.

The Priced Job Sheet filter selection parameters include:

Location - Enter the full Work Location to pick out jobs with matching entries in the Work Location field. Maximum 30 characters.

Notes - Enter the full Work Description to pick out jobs with matching entries in the Work Description field. Maximum 30 characters.

#### Choosing the Contract:

Making an entry in the Contract field will impose the selected Contract's prices on the SORs included on the Job(s). This allows you to report on the same Job or Jobs, priced under different Contracts.

If no entry is made in the Contract field - the report will use the Preferred Contract prices. The Preferred Contract is an optional field on the Additional tab of the Job form.

If no entry is made in the Contract field in the filter, the list will omit all Jobs that do not have a Preferred Contract specified on the Job form.

#### Priced Job Sheet

The Priced Job Sheet shows the selected Jobs, one Job per sheet<sup>\*</sup>, giving all the details which were entered on the Job form. The Job values are based either on the Preferred Contract (where one is entered for the Job), or by the selection of a Contract in the Priced Job Sheet filter.

The Priced Job Sheet filter selection parameters include:

Location - Enter the full Work Location to pick out Jobs with matching entries in the Work Location field. Maximum 30 characters.

Notes - Enter the full Work Description to pick out Jobs with matching entries in the Work Description field. Maximum 30 characters.

\*You may elect to print Multiple Jobs per Page by checking the check box in the top right hand corner of the filter. If Multiple Jobs per Page is checked, the report will page-break on change of Site, not for each Job.

#### Choosing the Contract:

Making an entry in the Contract field will impose the selected Contract's prices on the SORs included on the Job(s).

If no entry is made in the Contract field - the report will use the Preferred Contract prices. The Preferred Contract is an optional field on the Additional tab of the Job form.

If no entry is made in the Contract field in the filter, the list will omit all Jobs that do not have a Preferred Contract specified on the Job form.

#### **Evaluate Priced Job**

The Evaluate Priced Job list shows all the live Jobs priced under all the available (i.e. awarded) Contracts. A direct comparison can then be made of the cost of the work under one Contract as against the cost of the work under another Contract.

The Evaluate Priced Job filter allows selection by:

- 1. Job Number From / To
- 2. Action Officer
- 3. Status
- 4. Jobs Entered since (Date field)

#### **Create Jobs from Defects**

(Jobs from Defects module)

This utility is used in conjunction with the Condition Surveying module. It can be used at two different 'Levels':

#### Create one Job per Defect

Use this to select a range of Defects and raise one Job for each selected Defect. The details of the Job will be set based on the Defect, and the Job will be linked to the Defect.

The Action Officer for the Job will be determined by the Enquiry Subject Site rules if a Subject has been linked to the Defect Type. If no rule exists then the currently logged in User will be used. If an Action Officer record is not linked to the currently logged in User then the utility will not run.

Each Job created will automatically inherit the attributes from the Defect it was created from.

#### Create one Job per Feature

Use this to select a range of Features and raise one Job for each selected Feature. A Job will be raised for a Feature even if there are no Defects present.

Any existing Defect on the Feature that is not currently linked to a Job will be linked to the created Job, as long as the specified SOR Group is assigned to its Defect Type, i.e. as long as the work being done is relevant to resolving that Defect.

The currently logged in User must be linked to an Action Officer for this utility to continue as this Officer will be used on each Job created.

Each Job created will not automatically inherit the attributes from Defects when using the utility at this level.

**Note:** The Job Items are created using a specified SOR Group.

The top section allows the selection of Features by any of the parameters, or combination of parameters given. In particular, selection can be made by Observation Type, and Grade allowing Jobs to be raised as a result of a Condition Survey, on Features that do not have a Defect, but nevertheless have a Condition Grade that requires work to be carried out.

The central section allows the selection of Defects. This can be done using any combination of the available fields.

**Note:** If operating at the 'Create one Job per Feature' level, these criteria are used to select which Features are included, e.g. only Features on the specified Inspection Batch, or only Features with at least one Defect of the specified Defect Type. They will have no effect on which Defects are linked to the created Jobs, e.g. a Job could resolve a Defect of a different Defect Type to that specified, provided the selected SOR Group was assigned to the Defect Type of the Defect.

The top two sections can be used in combination so that if you wanted to raise Jobs, from a particular Inspection Batch, for a particular Feature Type, you would complete the 'Feature Type Like' field in the upper section, and the 'Inspection Batch' field in the central section.

The bottom section defines the Jobs that will be raised:

SOR Group:	Enter an SOR Group code, or select a group from the pick list. The pick list references the SOR Group lookup.

Quantity: Enter the required Quantities here, as Length, Width and Depth, or as a Quantity, or as a combination of these.

**Note:** Where some SORs in the group will require a measurement as 'Length, Width and Depth, and other SORs in the Group will require an entry for Quantity, All fields should be completed to deal with both.

These entries will be applied to the SOR Unit of Measure where:

- · 'No' has been selected in the 'Use Measurement' field
- Measurement type referenced in the 'Use Measurement' field does not use the same Unit as the SOR.

**Note:** Where 'Primary' or 'Specified' has been selected in the 'Use Measurement' field, the Job will reference the Features for a measurement of the appropriate Type. These measurements can only be used if Type references the same Unit of Measure as the SORs in the SORs Group.

Any SORs that do not reference the same Unit of Measure will use the measurements entered in the Quantity fields.

Cost Code:	Enter a Cost Code if you wish to supersede the Overriding Cost Code or Feature Cost Code.

Priority:	Enter or select the required Priority.
	The drop down list references the Priority Lookup and will set the Price Factor and starting Status for all the Jobs created in this batch.

Level:	Select from 'Create one Job per Defect' and 'Create one Job per Feature' as described above.
Location:	An optional free text field whose contents will be copied to the Location field of each Job.

#### **Job Batch Update**

The Job Batch Update utility allows details to be updated on a range of Jobs at once (like Action Officer, Status). The filter can be used to select the Jobs to be updated.

Use the fields above the grey line to specify the Jobs that will be included in the batch update.

The fields below the grey line are for supplying the changes which are to be made:

- New Status: The new Status that the selected Jobs should acquire.
- Action Officer: The new Action Officer to be assigned to Jobs.
- Effective: Today's date is entered by default. This can be changed.
- Estimated Start: Where the Estimated Start date is to be updated, enter the new date. Leave the field blank to update the Job Status without updating the Estimated Start date.
- Estimated Comple- Where the Estimated Completion date is to be updated, enter the new date. Leave the field blank to update the Job Status without updating the Estimated Completion date.

#### Maintenance Management

Follow Up: The Follow Up associated with the new Status. This can be changed by making a new selection from the drop down list. The drop down list references the Follow Up Lookup

#### Asset Maintenance\Maintenance Lookups

By: Calculated by adding the Follow Up to the Effective date.

Log Text: An optional free text field.

Click OK to display the preview, which will list all the selected Jobs with their old details. The Preview heading will give the new details (Action Officer, Status, etc.) that these Jobs will acquire if the preview is saved.

Save the Preview to update the Jobs. Close the Preview without saving to abort the update.

**Note:** It is mandatory to provide either 'New Status' or 'Action Officer' for the utility to proceed with updating jobs.

**Note:** Job Batch Update will ignore any Jobs that are at a current Job Status which has the 'Status Locked' checkbox checked. This will happen for all Users, including Users that have update access to the Data Security Key set in the Job Status Lookup. This is because the Job Status Notes are mandatory.

#### **Archive Jobs**

All Jobs are eventually archived. Once they have been paid, the system will automatically archive them, and they will subsequently not be seen unless specifically filtered for (unless the 'Prevent Non Routine Jobs from Archiving' flag is set on the Contract).

Jobs which are raised and cancelled, either before they are committed, or after they are committed but before they are paid, will not go through the payment procedure and therefore will need to be manually archived using the Archive Jobs utility.

Where the 'Prevent Non Routine Jobs from Archiving' is set on the Contract, Job will not automatically archive and therefore will need to be manually archived after the required period of time.

In either case, the following must be true for Jobs before they can be archived:

- Jobs must be at a Status that allows closure, i.e. does not have the 'Outstanding' check box checked. See "Asset Maintenance Standard Statuses" for an example of a Status which would allow a Job to be archived.
- Uncommitted Jobs which are on Orders must be removed from the Orders before they can be archived
- Committed Jobs must have an outstanding balance of zero. In other words, the full value must have been paid, and any remaining value must be reduced to zero by Variation. The Variation must be committed against the Job before the Job can be archived.
- All Job Costs, on Jobs linked to a Contract with a Payment Percentage Uplift, must have been included on a Payment Request.

For Uncommitted Jobs, if the Job is linked to a Defect that is currently at an 'Action Required' status, then the Defect will be moved onto 'No Action Required' when the Job is Archived.

The drop down selector allows the following selection to be made:

'All Unarchived' - To select from all live Job at an appropriate Job Status.

'Committed Only' - To restrict the selection to Committed Jobs at an appropriate Job Status.

'Uncommitted Only' - To restrict the selection to Uncommitted Jobs at an appropriate Job Status.

The Archive Jobs filter includes the following selection parameters:

- Notes Contains: Text entered here will select Jobs whose Work Description field contains that text as part of the full entry.
- Contains SOR Will select all Jobs which use this SOR Item

Item:

Named Selection: See **Asset Register - Feature Lookups** for a description of Named Selection and how to create a Named Selection

**Note:** Selection of Jobs can only take place from: Jobs whose Status is not checked as 'Outstanding', Committed Jobs with a zero outstanding balance, or Uncommitted Jobs not on an Order.

Click OK to display the preview, which will list all the selected Jobs for archiving.

Save the Preview to archive the Jobs. Close the Preview without saving to abort the archive.

#### Inventory updates on Job Archive

Where a Job is linked to Inventory Updates, that is that Inventory was updated through the Job form 'Other' button, the Inventory Updates will be undone where possible and the links will be deleted during Job Archiving.

Where undoing the Inventory Updates would lead to anomalies, a warning will be issued on Archive Preview, and a warning report will detail the issues relating to each Inventory Update link.

#### Import Jobs

The Import Jobs utility allows text files to be imported into the Job library.

To import, select the relevant files from the field pick lists, or enter the full path and file name. Select 'Tab Separated' or Comma Separated' from the "Import File Type" drop down list.

**Note:** See **Import Specification** for detailed information on import utilities used throughout Confirm.

#### **Job Reports**

These reports are used to report on Job data:

Customer Tracking Report - Reports on Job by customer as defined by the entries in the Customer Ref field of the Job form (not the Customer as defined by the Customer specified for the Feature and entered by default on the Job form).

Job by Location List - Reports on Jobs by Site and Location as defined by the Feature Id and Location fields of the Feature form.

#### Site History Report

#### Job Status Report

This is a general Job report, which includes the option to pick up Jobs by Actual Completion Date, Liability Date and Follow Up date.

**Note:** The Job Status Report references Jobs that are on an Order (regardless of whether the Order is committed) therefore Jobs that are not on an Order will not be included in the report.

#### **Job Precedence Report**

(Works Precedence module)

This report details each Job that has had a Precedence set. The default is for each Job to be displayed with its succeeding Jobs.

To display only preceding Jobs, select Show Predecessor Jobs from the drop down list at the bottom of the filter form.

To display both Preceding and Succeeding Job, check the Include [Predecessor, or Successor] Jobs check box.

#### Job Duration Report

This report is used to analyse the time taken for Jobs to go between two Job Statuses.

Use the filter to restrict the Jobs that are required for the report. There is an option for page orientation and to exclude negative values.

#### Site History Report

#### **Repair Performance Report**

This report is used to calculate the time taken to repair Features.

Jobs with a Preferred (Term) Contract will be included in the report. Where Defects are linked to a Job, the Defect with the earliest date will be used.

The filter has two options on which to base the calculation of the number of days taken to do the repair:

Start Date: Set the 'Start Date' filter option to one of the following:

'Initiated Date Excl. Enquiries' - The 'Days Taken' is calculated to be the difference in days between Defect Date, if available, Job Start Date, if available, or Job Entry Date, and the Job Actual Completion Date.

'Initiated Date Inc. Enquiries' - The 'Days Taken' is calculated to be the difference in days between Enquiry Logged Date, if available, Defect Date, if available, Job Start Date, if available, or Job Entry Date, and the Job Actual Completion Date.

'Order Commit Date' - The 'Days Taken' is calculated to be the difference in days between the Order Commit Date and the Job Actual Completion Date.

It is possible to restrict the Jobs which are retrieved by this report.

Show Jobs: Select from:

'All' - The report will include all Jobs, not just those linked to Enquiries or Defects.

'Linked to Enquiries (Primary) or Defects' - Select this to restrict the Jobs to those which are the Primary Job for an Enquiry or Defect.

'Linked to Enquiries (Primary)' - Select this to restrict the Jobs to those which are linked to an Enquiry.

'Linked to Defects' - Select this to restrict the Jobs to those which are linked to a Defect.

There are 'Contract' and 'Job' level options which can be set depending on the format required.

### **Non Routine Works**

The Non-Routine Works folder provides the tools for creating Works Orders and placing Jobs on the Works Orders.

The Order formalises the Job, by providing a Contract, a price, and the means of committing (and therefore eventually paying for) the work.

Works Orders are raised, and then committed. Up until the committal, alterations can be made directly to the Order. After committal the Order can only be altered by the raising and committal of another (Variation) Order.

#### **Order Details**

(Contract Management module)

The Order Details displays the Order Header. The Order Header will provide details of the Contract and Contract Area, and Work Type. All the Jobs that are put onto this Order must therefore be in the same Contract and Contract Area, and be ascribed to the same Work Type.

When a Committed Order is being viewed, all the fields will be disabled and may not be edited, unless the 'Allow Work Type Amendments on Committed Header ' option has been set in the **Contract Management System Settings** on page 90, in which case a new Work Type may be selected.

Contract Code: Enter, or select from pick list, the Contract under which this Order will be issued. The Pick list references the Contract Library and displays awarded Contracts, and Non-Term Contracts (Non Term module).

The user may only save Orders for current or future Contracts. If the user tries to save an Order attached to an expired Contract then the following error will be generated:



#### **Contract Preparation\Contract**

Contractor: If an awarded, term Contract was selected, the Contractor who 'owns' the Contract will be automatically entered and the field will not be editable.

If a Non-Term Contract (Non-Term module) is selected then the field becomes available for the selection of a Contractor.

The pick list for this field references the Contractor library.

#### **Contract Preparation\Contractors**

Order Number: A number will be automatically assigned from the Seed numbers for the User's Work Group and the selected Contract when the Order header is saved. See **System Administration/Work Group** for details on setting seed numbers for Orders.

The number of an existing Order can be entered here to recall that record.

Notes: An optional, free text field

Status field: This field is not editable and will display the current status of the Order.

'Uncommitted' - the Order has not been committed.

'Uncommitted (Pending)' - where the Contract has 'Order Commit Authorisation' checked, the Commit Order utility will set the Order to 'Pending' while awaiting authorisation for full committal. The Order and Jobs with the 'Pending' flag set have restricted editing allowed, on the same basis as for Committed Orders.

'Committed' - the Order is committed, and at least one of the Jobs on the Order remains open.

'Archived' - the Order is committed and all the Jobs on the Order have been paid and closed

- Date/Time: The current date and time is automatically entered. The field can be edited.
- Set Completion: An estimated completion can be entered here. (Optional)

Contract Area: Select the appropriate Contract Area from the drop down list.

The drop down list references the Contract Area Lookup.

#### Site Register\Site Lookups\Operational Site Lookups

Work Type: Enter, or select from the drop down list the appropriate Work Type. If a Contract has been specified in against the selected Work Type and one has not already been entered on this screen, it will be entered in the Contract field.

The drop down list references the Work Type Lookup

External Ref:	An optional, free text field
PO Number:	Shows the purchase order number for the Order. It is not available when manually entering Orders, and can only be populated by importing a PO Number with the Financial Interface XML Agent. If the Order has no purchase order number this field will not be visible.

Order Value:	Read only field, which will display the total value of the Order when Jobs are added.

#### Links button

#### Commit button

The Commit button is only available on uncommitted Orders and displays the Order Commit Batch filter, with the details of the current Order entered, for Committal of the Order. See **Commit Orders** on page 46 for more information on committing Orders.

#### Archive button

Redundant headers can be Archived with the Archive button. After prompting the User for confirmation the Status of the Order Header will be set to 'Archived'.

The button will be disabled if there are Jobs attached (in which case the 'Clear' button can be used) or the Order has already been Archived.

#### **Print button**

Displays the Order Print filter, with the details of the current Order entered. See **Print Orders** on page 47 for more information on committing Orders.

#### Add Job button

The Add Job button displays a screen that allows the user to add Jobs to a Committed Order. The button is only available on Committed Orders if the 'Add Jobs to Committed Orders' check box is ticked on the Job System Settings screen..

#### Asset Maintenance\Job System Settings

Existing Jobs can be added, or new ones created and then added.

An existing Job can only be added to the Order if:

- It is Uncommitted.
- AND it does not have any SOR Items assigned.
- AND it is not already on an Uncommitted Order.
- AND it does not require a **User Commit Limit** on page 95 to be generated.

If a new Job is created from the Add Job button then it will be automatically added to the Order, and set to a Committed Job status. SOR Items cannot be created for new Jobs added to Committed

Orders because they are not allowed to have any value. However, SOR Items can be added or varied for these Jobs using Variation Items, Payment Items or Payment Request Items.

Since no SOR items are created for these Jobs, they cannot be processed via the Payment Commit process as it requires Payment Items on all Payment Jobs. Jobs that have a Payment Item added subsequently can be archived automatically by the Payment process, or if they have no value then they can be archived with the **Archive Jobs** on page 30 utility.

Jobs can be added to Orders in two ways:

- A pre-existing Job can be added to the Order
- · A Job can be directly created in the Order Job form

To add a pre-existing Job or range of Jobs:

Jobs may have been created in the Job form, or created as a result of a batch process such as Create Jobs from Regimes, or Create Jobs from Defects. These Jobs can be added to the Order.

A single Job can be added by entering the Job number in the Job Number field. Use the pick button on the Job Number field to display all available Jobs. The pick list references all Uncommitted and Live Jobs for the selected Contract Area (i.e. the Contract Area entered on the Order Header)

A range of Jobs can be added using the 'Batch' button on the right-hand side of the Order Job form. See **Batch button** on page 42.

Order Jobs can be created from scratch in the same way as Jobs are created in the Job form. See "Job"

An Order Job differs from a **Job** on page 7 in some respects, and has some additional fields and buttons.

Contract: Copied from the Order Header

- Order No: Copied from the Order Header
- Cost Code: Where a default Cost Code is set against the Work Type, and the Order is for the Contract specified against the Work Type, the default Cost Code will be entered.

The Work Type Cost Code default is set in the Work Type lookup.

Maintenance Management\Contract Management lookups

The Cost Code entered here will be used as a default for new Job Items. Leave this blank if the Job Item Cost Code is to be derived from the Feature or overriding Cost Code.

Job Type: This field will default to the Job Type assigned to the Work Type of the Order Header when a new Order Job is being entered.

The Job Type default is set in the Work Type lookup.

Maintenance Management\Contract Management lookups

This can be changed if not applicable for the current Job. The pick list references the Job Type lookup.

#### Asset Maintenance\Maintenance Lookups

This field may have been set by a different default depending on where is was created from e.g. Enquiry Subject Job, Defect Type, Job System Settings or Maintenance Regime.

If an existing Job which has the 'NCA' Job Type assigned is added to an Order then the Job will be updated to match the Job Type from the Work Type assigned to the Order.

- Job Value: The Contract Rates will be used to work out the cost for the current Job.
- Priority: Where a default Priority is set against the Work Type, and the Order is for the Contract specified against the Work Type, the default Priority will be entered instead of the Priority set in the General Systems Settings.

The Work Type Priority default is set in the Work Type lookup.

Maintenance Management\Contract Management lookups

Price Factor: Only Price Factors associated with the Contract selected on the Order Header will be displayed in the drop down list.

## **Contract Preparation\Contract - Price Factor tab**

#### Additional tab

This tab is very similar to the Additional tab on the Job screen. The following fields are different:

Minimum Value: The minimum Value is entered here - derived from the Minimum Job cost set for the Price Factor under the Contract. Contract Preparation\Contract - Price Factor tab Can be edited for this Job.

The Minimum Value will override the Job Value if the Job Value is less than the Minimum Value.

Fee Percent: (Administration Fee Recovery module)

This will be entered automatically when the first SOR is added to the Order Job. Can be edited for this Job.

Minimum Fee: (Administration Fee Recovery module)

This will be entered automatically when the first SOR is added to the Order Job. Can be edited for this Job.

Fee Income Code: (Administration Fee Recovery module)

This will be entered automatically when the first SOR is added to the Order Job. Can be edited for this Job.

**Note:** 'Fee Percent', 'Minimum Fee' and 'Income Code' details are derived from the first SOR added to the order - even though subsequent SORs added may carry a different Fee Work Category and therefore may have imposed different values. The Fee Rates are set up in the Administration Fee Recovery folder - see Finance & Budgets for details on how to set up Administration Fee Recovery.

#### Status tab

The Status tab gives details of the current stage of the Order Job. The Stages an Order Job may pass through are defined as Statuses. Most fields are the same as the Job **Current Status tab** on page 12 tab, with the exception of 'PO Number' which shows the Purchase Order number, if set. If the Order has no PO Number this field will not be visible.

Each Status is assigned a log number, is logged by a user, and assigned to an Action Officer.

**Note:** This tab has all the compulsory fields completed from defaults. It is not therefore necessary to access it unless you want to change the defaults.

#### Status Log tab

Finance Period: Select the Finance Period in which you want the payment to be made.

# **Batch button**

The Data Source should be at Inventory Item level; it may contain a mixture of:

- End dates to existing Inventory Items, and
- New Inventory Items, with their Attribute values in columns

The utility also includes Job details in order to:

- Create a Job for each distinct Feature whose Inventory is being changed (multiple Jobs where different Job Sequence Numbers are supplied)

- Payments to be made.

Commit button will display the Works Order Commit - preview which will give the Order Number(s), Job Number(s) and values. The last column of the preview will report on whether the Jobs or Order can be committed. If the Order cannot be commit a short line of text will describe the problem. A problem with any single item on the Order will prevent the whole order from committing.

To re-select the Orders Re-filter to open the Order Commit Batch filter:

Order Number: An Order number or range of Order Numbers can be entered here.

Order Date: A date or range of dates can be entered here.

If the selected Contract has the 'Order Commit Authorisation' flag checked then the Orders must receive authorisation before they can be fully committed and will enter a Pending status in the meantime. Please refer to **Order committal authorisation** on page 46 for more detail.

If no problems are reported, or to commit orders without problems, click on the 'Save' button.

# Order committal authorisation

(Financial XML Agent module)

Confirm can be configured to request authorisation from an external financial system before allowing Routine and Non-routine Works to be committed. This authorisation process can be selected individually for each Contract. The facility is enabled when the Financial XML Agent module is present and the 'Authorisation Required' option is selected on the Contract lookup in Contract Preparation. The Financial XML Agent must also be configured correctly so that it can contact the external financial system. When the user attempts to commit Orders and the assigned Contract has 'Authorisation Required' selected, the Commit Order utility will set the Order Status to 'Uncommitted - Pending' while awaiting authorisation for full committal.

For Non-Routine Works, the following apply to Orders and Jobs in the 'Uncommitted - Pending' status:

- Restricted editing is allowed, on the same basis as for Committed Orders.
- The works order number is added to the job.
- The cost code commitment values are not updated with the Order cost code values (the Order remains 'uncommitted').
- The Job status for Jobs on the 'Pending' Order is set to the Order Pending system setting.

For Routine Works, the following applies when a Order or Job is 'Uncommitted - Pending':

• The cost code commitment values are not updated with the Order cost code values (the Order remains 'uncommitted').

## **Obtaining Authorisation**

Orders and Jobs will remain in the 'Uncommitted - Pending' state until authorisation is obtained.

Authorisation is sought though an automated export of 'Uncommitted - Pending' Orders to an external financial system and an import of authorisation from this external system.

Orders which have been set to 'Uncommitted - Pending' since the last Financial XML Interface run are extracted via the Financial XML Interface, and exported. The external system should send back a response either providing a Purchase Order Number, and thereby authorising the exported Order, rejecting the Order, or leaving it unchanged as 'Uncommitted - Pending'.

- If the Order is authorised, the Status of the Order is set to 'Committed', the Purchase Order Number is stored against the Order Header and the cost code commitment values are updated with the Order cost code values. The order status will then become 'Committed'. A Purchase Order Number assigned through authorisation cannot be edited.
- If no Purchase Order Number is supplied for an exported Order then the Order is deemed rejected, the Order returns to the 'Uncommitted' status.
- If no response is received for a particular exported Order then that Order will remain in the 'Uncommitted - Pending' status.

A Job Status Log record is created as follows:

- When the Order is authorised, the status used is the Order Committed system setting.
- When the Order is rejected, the status used is the Order Authorisation Failed system setting.

# Print Orders

Orders can be printed whether they are committed or uncommitted. The Order print will show whether the Order is committed or not.

Print Order displays the Order Print Filter:

Contract: A Contract must be entered.

Order Number: An Order number or range of Order Numbers can be entered here.

Route: If a (Site) Route is entered, the Works Order print will list the Jobs in Route order. Jobs on Sites that are not in the Route will appear at the end of the order print in alphabetical order.

Status: Select from drop down list - Committed Only, Uncommitted Only, Archived, or Live. **Note:** This selection will only be effective where a range of Orders has been selected. Where a single order is to be printed, the system will ignore any selections in this field and print the Order. Commit Date Use these fields to restrict the Orders printed to a specific or range of Com-From / To: mitment dates. Unprinted Orders Uncheck this to print all the selected Orders, regardless of whether they have the 'Printed' flag set. only: Note: This selection will only be effective where a range of Orders has been selected. Where a single order is to be printed, the system will ignore any selections in this field and print the Order. **Update** 'Printed' Confirm will register the fact that an order has been printed - Job Statuses flag can be updated on this basis if a link is made in the Contract Management System Settings. Uncheck this box if you do not wish Confirm to update anything on account of this print. Select the range of Order Copies from the pick lists. A Summary copy prints only the Site, Area, Classification, Plot Number and Feature Type or Feature ID for each Job

Click on Ok to display the Preview. Click on the Print Button in the Preview to send the Order to the printer.

# **Print Work Summary**

A Work Summary details the Jobs, Site by Site, in a table format. The details shown are limited to: Site, Area, Plot Number, Location, SOR Item and Quantity

Print Work Summary filter criteria include:

Status: a pre-set drop down list from which All, Committed, Uncommitted, or Archived can be selected.

Show Long Description: check this box to show the SOR Item long description on the Work Summary

Show Values: check this box to include the Job Values.

Click on Ok to display the Preview. Click on the Print Button in the Preview to send the Work Summary to the printer.

# Job Status Update

The Job Status update filter allows a range of Jobs to be selected which can then be scrolled through, to update the Status of each Job.

## Work Order Status Report

# **Routine Works**

The Routine Works folder contains all the forms, utilities and reports necessary to raise and commit Routine Work, print Orders and Work Summaries, and analyse the Routine Work.

Routine Work can be calculated by the system from the routine work that has been programmed into the system by Maintenance Regimes allocated to Features.

Routine Work can be browsed through the Order Header, and a Works Order can be printed.

# **Calculate Routine Works**

The Calculate Routine Works utility will calculate a Works Order based on the Routine Works programmed into Confirm. Works Orders are Contract Area specific, and a separate Works Order will be raised for each Contract Area in the specified Contract.

The work calculation will be based on the Features in the appropriate Contract Areas, their measurements, and the SOR Items and occasions given in the Maintenance Regimes allocated to them.

The SOR Items are priced by reference to the Routine Price Factor of the appropriate Contract. The Routine Price Factor is set in the General Systems Settings.

There will be a separate header for each Contract and Contract Area, and for each range of Finance Periods selected in the 'Calculate Routine Works' filter.

Use the Find button to select an Order or range of Orders, or enter the Contract and Order number into the form and press the Tab key.

The Order Header displays the Contract, the Order Number (which will have been assigned from the Work Group seed numbers when the details were calculated and saved), the date and time the Order was raised, the Contract Area, and Work Type. The Order Header will also show whether the Works Order has been committed or not.

The lower pane lists Sites, Regimes and Plot No (or Aggregate\*) for the work that has been raised. The far-right column displays the first Finance Period for which work has been raised in this Works Order.

To view an item of Work in more detail, select it from the list in the lower pane, and click on the 'Detail' button.

\*Note: Where the Maintenance Regime has the 'Aggregate' check box checked, all the work under that Regime in the same Site, with the same Customer and Cost Code, will be totalled, rather than displayed as a series of plot numbers. See **Asset Maintenance\Maintenance Regimes** for information on aggregating Regimes.

#### **Routine Maintenance - Order Job**

Each Regime from which work has been ordered for this Site will be displayed as a Routine Maintenance Order Job in the Routine Maintenance Order Header. Where the Regime is Aggregated there will be one Order Job for all the work under that Regime on the Site. Where there is no Aggregation, a separate Order Job will have been created for each Feature that carries the Regime.

The Routine Maintenance - Order Profile form carries across the information from the Routine Maintenance - Order Job, and from the Routine Maintenance - Order Item form. There is a separate Routine Maintenance - Order Profile form for each Finance Period, Week, and Day for which work using this SOR Item has been ordered. This will be based on the Maintenance Regime. In other words: if the Regime from which this work has been derived specifies work at Period level only, then only Periods will be displayed in the Routine Maintenance - Order Profile.

Confirm can be configured to request authorisation from an external financial system before allowing Routine and Non-routine Works to be committed. The facility is enabled when the Financial XML Agent module is present and the 'Authorisation Required' option is selected on the Contract lookup in Contract Preparation. The Financial XML Agent must also be configured correctly so that it can contact the external financial system.

When the user attempts to commit Orders and the assigned Contract has 'Authorisation Required' selected, the Commit Order utility will set the Order Status to 'Uncommitted - Pending' while awaiting authorisation for full committal.

For Non-Routine Works, the following apply to Orders and Jobs in the 'Uncommitted - Pending' status:

- Restricted editing is allowed, on the same basis as for Committed Orders.
- The works order number is added to the job.
- The cost code commitment values are not updated with the Order cost code values (the Order remains 'uncommitted').
- The Job status for Jobs on the 'Pending' Order is set to the Order Pending system setting.

For Routine Works, the following applies when a Order or Job is 'Uncommitted - Pending':

• The cost code commitment values are not updated with the Order cost code values (the Order remains 'uncommitted').

## **Obtaining Authorisation**

Orders and Jobs will remain in the 'Uncommitted - Pending' state until authorisation is obtained.

Authorisation is sought though an automated export of 'Uncommitted - Pending' Orders to an external financial system and an import of authorisation from this external system.

Orders which have been set to 'Uncommitted - Pending' since the last Financial XML Interface run are extracted via the Financial XML Interface, and exported. The external system should send back a response either providing a Purchase Order Number, and thereby authorising the exported Order, rejecting the Order, or leaving it unchanged as 'Uncommitted - Pending'.

- If the Order is authorised, the Status of the Order is set to 'Committed', the Purchase Order Number is stored against the Order Header and the cost code commitment values are updated with the Order cost code values. The order status will then become 'Committed'. A Purchase Order Number assigned through authorisation cannot be edited.
- If no Purchase Order Number is supplied for an exported Order then the Order is deemed rejected, the Order returns to the 'Uncommitted' status.
- If no response is received for a particular exported Order then that Order will remain in the 'Uncommitted - Pending' status.

A Job Status Log record is created as follows:

- When the Order is authorised, the status used is the Order Committed system setting.
- When the Order is rejected, the status used is the Order Authorisation Failed system setting.

## Print Routine Works

# **Routine Maintenance Reports**

The Routine Maintenance Reports give details of Routine Works Orders, and Routine Variation Orders, committed in the system.

#### Maintenance Management

These can be seen as Summary reports giving a total for the whole amount committed on Works Orders in a Contract, the total committed on Routine Variations for that Contract, and the final amount now committed in that Contract, after adjusting for the Variations. The Report Level can be set to provide a more detailed report.

Both Annual and Period reports are available. The Annual Reports will simply give the totals for the range of Periods selected. The Period Reports will give information on each of the Periods in the selected range.

Annual and Period reports can be run by Contract Area, by Cost Code, by Customer and by Site.

The information about which Cycle (and therefore which Features) is currently involved is given by the entry in the 'Current Cycle' field of the Maintenance Regime.

# Asset Maintenance\Maintenance Regime

When a cycle for a Regime has been finished, the Regime 'Current Cycle' field should be updated to the next cycle of work that will be undertaken. This can be done directly in the Maintenance Regime form, or it can be done by a batch process using Regime Cycle Batch.

Increment Cycle: Check this to increment the 'Current Cycle' on the selected Regimes by 1.

- Set Cycle: Enter a number to be entered into the 'Current Cycle' field of the selected Regimes. Overrides the 'Increment Cycle' field.
- Regime Like: Enter the Regime, or code segment and wildcards, to select the Regimes to be updated. Leave blank to update all the Cyclic Regimes.

Click OK to display the preview report. Save the preview to update the Regimes. Variation Details displays the Variation form.

# **Variation Orders**

A Variation Order is raised and committed to make changes to committed Works Orders.

Each Variation Order will have a numbered Variation Header, which is numbered within the Contract from the Work Group Seed numbers.

# Variation Details

Variations are created to vary details of Committed work. This work can be either Routine or Non-Routine.

Both the 'Batch' and Inventory Variation utilities create Routine Maintenance - Variation Jobs. A Variation Job is created for each Regime, Customer and Plot (or aggregation of plots) in which a change will be made.

The filter is used to define the location, the work, and the occasions for which the Variation is to be carried out.

The fields above the grey line define the Sites, Features and Regimes on which the work is to be varied.

The fields below the grey line define the type of Variation and set the Occasions. These fields include:

Type of V.O: Select from the drop down list:

Cancellation: to cancel the work specified in the filter. If cancellation is selected, the Finance Period fields will be giving a range through which the work is to be cancelled.

Reschedule: to move occasions of work from one period to another. If reschedule is selected, the 'From Finance Period' fields will indicate which Period (Week and Day) currently contains the work, and the 'To Finance Period' fields will be specifying the Period (Week and Day) to which the work is to be rescheduled.

Additional: to add an occasion of work. If Additional is selected, the 'From Finance Period' fields will grey out leaving the 'To Finance Period' fields for the entry of the occasion(s) of the additional work.

Number of Occa-<br/>sions:To specify the number of occasions, in each of the Periods specified in the<br/>Finance Period fields, which are to be cancelled, rescheduled, or added.

From FinanceThe function of this field will alter with the Type of V.O. selection made above,<br/>and the field will not be available at all if the Type of VO 'Additional' has been<br/>selected.

If only the Finance Period is entered (and Week and Day are left 'Not Specified'), then the selection of work for the Variation will be made from work that was originally specified (in the Maintenance Regime) at Period level.

#### Maintenance Management

Week can be selected without completing Finance Period (in which case the appropriate Finance Period will be automatically entered). If a Finance Period is entered first, then the selection of a Week will be limited to the Weeks associated with the entered Finance Period.

The Inventory Variation utility will identify changes in the Inventory (changes to Sites, Features or Regimes), which have taken place since the Routine Maintenance Works Order was committed, and create Routine Maintenance - Variation Jobs to reflect those changes.

To run the Inventory Variation utility click on the 'Inv VO' button in the Routine Maintenance - Variation Job form. The Inventory Variation Order Filter is displayed:

Finance Period: Enter the Finance Period from which the changes in the Inventory should be effective in the Works Order. The pick list references the Finance Period library.

Finance and Budgets

Week: Do not alter the default for 'Not Specified'.

The section under the grey line is to define the parts of the Inventory in which the changes have taken place. The utility will then restrict the comparison to these parts of the Inventory. Leave this section of the filter blank to have the comparison made over the whole Inventory (but be aware that this may take some time if your Inventory is large).

Click OK to run the utility. A Preview report will be displayed, listing the changes that have been found when the Inventory is compared with the Works Order in the Periods specified. The report will give a short line of text, for each difference found, indicating the nature of the change. Click on 'Save' to create the Routine Maintenance - Variation Jobs necessary to amend the Work Order.

**Note:** Finance Periods are identified using dates saved on the Routine Works Order. If the Finance Period dates have been amended since the Works Order was Saved the utility will be unable to identify the Finance Periods used on the Order and the Save button will be disabled.

The form will be Blank when it is first displayed, with the next available item number entered in the Item Number field. You may use this form to add new Items to the Job.

If the Cost Code Protection settings have been set on the Job System Settings screen, then Cost Code will be set from the Job's Cost Code and it cannot be modified here.

#### Asset Maintenance\Job System Settings

#### To amend existing Items:

Enter into the Item Number field the number of the item to amend, or use the pick button on this field to select it. The pick list will display all the items currently on the Job.

When an existing Item is entered, the Item details are brought in and greyed out. Only measurement can be amended:

#### **Commit Variations**

Click on OK to display the Preview. The preview will display the Variations by Work Order number and Site. The last column of the preview will report on whether the Variations can be committed. If the Variation cannot be committed a short line of text will describe the problem. A problem with any single item on the Variation will prevent the whole Variation Order from committing.

If no problems are reported, or to commit Variation without problems, click on the 'Save' button.

# **Print Variations**

Variations can be printed whether they are committed or uncommitted. The Variation print will show whether the Variation is committed or not. Print Variations allows a range of Variations to be printed.

Variation Number: A Variation number or range of numbers can be entered here.

- Route: If a (Site) Route is entered, the Variation Order print will list the Variation Jobs in Route order. Variation Jobs on Sites that are not in the Route will appear at the end of the order print in alphabetical order.
- Status: Select from drop down list Committed Only, Uncommitted Only, Archived, or Live.

**Note:** This selection will only be effective where a range of Variations has been selected. Where a single Variation is to be printed, the system will ignore any selections in this field and print the selected Variation.

Commit Date Select a specific or range of Commitment dates to restrict the Variation print by.

Order Copy: Select the range of Order Copies from the pick lists. The pick list references the Order Copy library. See "Works\Non Routine Works\Order Print Copy" for information on setting up Order copies.

Click OK to display the Preview. Click on the Print Button in the Preview to send the Variation to the printer.

# Variation on Price

Variation Orders will not normally take account of changes in Rates that have taken place since the original Works Order was committed. Varied works will use the rates current when the original order was committed.

If there is a requirement to update Jobs on Committed Orders, and\or Jobs on committed Payment Batches, to reflect new rates, then the Variation on Price utility can be used to do this.

This utility will select committed Non-Routine Orders whose Contract or Site BOQ rate has changed (after a Rate Uplift for instance), and either update the SOR Item rates, or make up the difference in old and new values using an adjustment SOR Item.

The Value of the committed Variation will then be included on the next Payment Batch that is created (if a Payment Batch is not already requested in the Variation on Price filter).

# Pre-requisites for Variation on Price

In order to carry out a Variation on Price the following must be in place:

- There must be suitable, 'currency' (pound or dollar) SORlitem, present in the Contract Rates for the Contracts in which Variation on Price is to be carried out. This may be the standard currency Item, or it may be a specially created 'Variation on Price' Item (priced 'per [currency unit]', and given a rate of '1'). Asset Maintenance\SOR item
- A new Job Status must be created which has the outstanding, commit, complete and payment check boxes checked. Asset Register\Maintenance Lookups
- The Contract Management System Setting must have the Variation on Price SOR Item set, and the Price Variation Status set.

All Filter fields (other the 'Processing Required') are optional and include:

- Include Payments: Check this to include archived Jobs, that is those Jobs on committed payment batches

Committed (but not archived) Jobs will be paid in usual way, either by a Request for Payment, or by setting the Status to one that allows payment. The Jobs can be put onto a Payment Batch as soon as they are authorised and the amended value will be paid.

Archived Jobs - these will have the 'Variation on Price' Status set. This Status allows payment, therefore these Jobs can be included on a payment batch without any further processing.

# **Contract Management Lookups**

Contract Management Lookups contains libraries and System Settings for the Contract Management module and the Contractor Invoice module.

# **External System**

(Customer Services Publication Agent, Corporate Issue Agent, CRM Agent & Confirm Connector, Contractor Access XML Agent )

The External System is used to identify Enquiries that may have been generated, or are maintained, by external CRM systems.

An External System can also be associated to Confirm Jobs to identify the corresponding Job and Order record within the external system.

System Name:	The user facing name for the external system.
System Number:	This is assigned by Confirm and cannot be modified. It is this value that is used to identify the external system in any Imported or Exported records.
Import File Path:	Corporate Issue Agent only - Enter a file path where the agent will poll for new imports.
Export File Path:	Corporate Issue Agent only - Enter a file path where the agent will export Status Updates to.

**Note:** If any Enquiries exist in Confirm with a matching External System Number then that External System record cannot be deleted.

# Work Type

Contract:

The Work Type lookup provides a series of labels for applying to Order Headers. These labels then provide a reporting tool so that Works Orders of a particular Work Type can be picked out for a report. Additionally, where the Administration Fee Recovery module is present, the Work Type plays a part in determining the Fee Percent and the Minimum Fee for the work on an Order.

Code: Up to four alphanumeric characters

Name: Up to thirty characters

The next four fields, Contract, Cost Code, Priority and Job Type, are settings that may be used to define defaults to be used for new Orders and Order Jobs created for this Work Type.

The default Contract used in the Order Header and Job Order screens when a new Works Order is created with this Work Type.

Cost Code: (Optional)

The Cost Code to be used when manually creating a new Job on a Works Order with this Work Type.

In addition, when an existing Job is manually linked to an Order with this Work Type, this Cost Code will be applied if the Job does not itself have a Cost Code.

Priority: (Optional)

The Priority to be used when manually creating a new Job on a Works Order with this Work Type.

Job Type: (Optional)

The Job Type to be used when manually creating a new Job on a Works Order with this Work Type.

# **Invoice Payment Systems Settings**

(Contractor Invoices module)

The Payment Systems setting set defaults for:

Payment Cat- egory:	Provides a default Payment Category for new SOR Items. Select from the drop down list. The drop list references the Payment Category Lookup.
Tax Status:	Provides default Tax Status for new Payment Categories. Select from the drop down list. The drop list references the Tax Status Lookup
Тах Туре:	Provides a default Tax Type for new Contracts. Select from the drop down list. The drop list references the Tax Type Lookup.
	<b>Note:</b> The default Tax Type must be zero-rated and cover at least as long a date range as the Contract.
Tax Adjustment Limit:	Enter here the total Tax Adjustment which may be added to a Tax Type in a Request Job.

#### **Order Print Map System Settings**

(Works Order Map Print module)

The Order Print Map System Settings define the size of map images in pixels and the way in which URL addresses are constructed in order to retrieve map images from a web server.

Map Width / Height:	Set the size (in pixels) for the map on the Order Print.
Copyright Text:	Enter the copyright text that will appear next to the map on the Order.

# Map Settings:

Confirm can download maps from internal or external web servers and will identify the supported image formats of GIF or BMP.

URL addresses are constructed dynamically by substituting \$ASSETID\$, \$GROUP\$, \$XCOORD\$, \$YCOORD\$ with relevant attribute values which are stored against a Job or Feature to which that Job is linked as following:

- \$AssetID\$ is substituted by the Central Asset Id of the Feature.
- \$GROUP\$ is substituted by the Feature Group code of the Feature

- \$XCOORD\$, \$YCOORD\$ are substituted by Easting and Northing coordinates of the Job or if these are not defined by Easting and Northing Centroid coordinates of the Feature.

It is also possible to obtain map images indirectly as following:

- Send a URL query to obtain an html page which includes a link to the required map image
- Search within a received html document for another URL address pointing directly to a file, which stores required map image. Search will be performed by finding 'Map URL Search' string predefined in the Order Print Map System Settings, which would indicate the beginning of a required URL link.
- New query will be constructed by joining predefined 'Map URL Prefix' with the found string and send to the web server to obtain the required map image

An example Map URL Line might look like this:

http://<myserver>/planaccess/getmapimage.asp?zoom=500&easting=\$XCOORD\$&Northing=\$YCOORD\$&mapwidth=500&mapheight=400&arrowpointer=true

Where <myserver> would be substituted with the user's own particular map serving site.

If PlanAccess is being used as the map server then the URL Search and Prefix fields must be left blank and the Copyright text is not necessary as PlanAccess does this automatically. PlanAccess allows other parameters in the URL Link field. These are described in section 4.10 of the PlanAccess developer's manual.

**Note:** If no map appears when the Order is printed; keep the Order Print screen open and look in the local "temp" directory (e.g. "C:\Documents and Settings\MyUserName\Local Settings\Temp"). There will be a log file which can be viewed to find out why it has not appeared (e.g. sbs12.log) - sort by date to locate it. Common reasons for this could be that there are missing X and Y coordinates for the Feature or Job, or the internet Proxy Settings are incorrect - indicated by a "Get Internet File from URL Error:502" message.

# **Street Works Initiation from Jobs**

The Street Works Initiation from Jobs functionality provides the ability to automatically create Street Works Notices when specific updates are made to Jobs either interactively via the Confirm Client or externally e.g. ConfirmConnect® / Contractor Access XML Agent.

The following sections will show how to setup Street Works Initiation from Jobs.

They will also clarify the Notice types that can be created and the triggers that automatically create that Notice.

# Configuration

# Module Requirements

The following modules are required.

- 3400 Street Works Register
- 3420 Street Works Initiation
- 1215 Job Creation
- **Note:** When the 3420 Street Works Initiation module is activated the Notice button becomes available on the Job and Order Job screens.

# Job Type Lookup

Notice creation from Jobs is governed by the Street Works Noticing field in the Job Type lookup.

The field is a drop down menu with the following options:

• **None Required:** No notices can be created either manually or automatically for Jobs with this set on their Job Type. The *Notice* button is unavailable on the *Job* and *Order Job* screens.

- **Manual Noticing:** Only manual Notices can be created for Jobs with this set on their Job Type. The *Notice* button will be enabled on the *Job* and *Order Job* screens so the user can select *Create Notice* to manually create a Notice via the Street Works Notice wizard.
- Initial Notice Manually Raised: Jobs with this set on their Job Type must create the first Initial Notice manually via the *Noticebutton> Create Notice* option. Subsequent Notices will be generated automatically when the required triggers are present.
- Automatic Noticing: All Notices will be created automatically for Jobs with this set on their Job Type when the required triggers are present. In addition manual Notices can also be created via the Noticebutton> Create Notice option.
- **Note:** In case Street Works Notice is selected as either 'Automatic Noticing' or 'Initial Notice Manually Raised', Street Works Duration field gets enabled. Set the value in this field for defaulting the duration of the Automatic Notice Permit being created while scheduling the Job from Workzone.

# Action Officer Lookup

For a Notice to be created against a Job it must be assigned to an Action Officer that has an Organisation configured in the **Action Officer** lookup.

The *Organisation* field on the lookup is used for this purpose. In addition the assigned Organisation must be a marked as a *Notice Initiator* in the **Organisation** lookup under the *Additional* tab.

# **Street Works Settings**

The following Street Works settings screens need to be properly configured to automatically generate Notices from Jobs:

- · Street Works Notice Default System Settings screen.
- Organisation lookup.
- Street Works System Settings screen.

Please refer to the relevant documentation in regards to the setup of these screens.

# Priority Lookup

The **Priority** lookup (via the *Urgency* field) is used to set the *Street Work Type* on any Notices that are automatically created from Jobs.

The following options are available from the *Urgency* field:

- **Standard:** Set this option to a create Notices with a Street Work Type of *Standard, Minor* or *Major* when a Job is set to this priority. The specific Street Work Type used will be determined by the duration of the Works and the notification period supplied.
- **Emergency:** Set this option to create Notices with a Street Work Type of *Emergency* when a Job is set to this priority.
- **Urgent:** Set this option to create Notices with a Street Work Type of *Urgent* when a Job is set to this priority.

# Job Status Lookup

The Job Status is one of the triggers that regulate when automatic noticing takes place.

In the **Job Status** lookup the two trigger options that need to be set are:

- In Progress check box: When a Job's first reaches a status that has this option ticked this indicates to Confirm that an *Immediate* Street Works Notice should be created (if all triggers are set).
- Initiate Street Works check box: When a Job's at a status that has this option ticked this indicates to Confirm that either a *Minor, Standard* or *Major* Street Works Notice should be created (if all triggers are set).
- **Note:** A Job Status should not have both these options ticked as this will result in notices not being created as they are used for separate functionality.

#### Street Works Initiation from Jobs Override Setting

In Confirm under *System Administration > Security > User Security > Street Works* there is a *Validation Override* option. This option is used to govern whether notices will be created if all conditions are not met or whether to display an error instead.

With the override switched on the user will be presented with warnings as opposed to errors if there are details missing that are required to accurately create the notice. As they are warnings the Notice will still be created.

If the override is switched off any errors encountered will prevent a Notice being completed.

## **Creating Automatic Notices**

This section outlines the triggers or information that need to be present on a Job in order for it to create automatic Notices.

Each Notice type has different triggers and only one Notice will be created automatically at a time.

If the automatic noticing being created is for a Permit Authority, then the Permit equivalent Notices will be created instead.

There are some general Job conditions that need to be met regardless of which Notice is to be automatically created which are covered in the following section.

# General Trigger Conditions

- The *Street Works Noticing* field of the Job's Job Type must be set to *Automatic Noticing* or *Initial Notice Manually Raised*. If the latter option is selected the Initial Notice for planned works must have been created before any subsequent automatic noticing takes place.
- The Job's Priority *Urgency* flag must be set to either *Standard*, *Urgent* or *Emergency*.
- The Action Officer assigned to the Job must be assigned to an Organisation that is a *Notice Initiator*.
- The Street assigned to the Job that the Notice is being created for should have a *Highway Authority* Street Interest set.
- Ideally coordinates should be set on the Job. These are not mandatory but if they are not present a warning will appear. The Notice will be created but it will not be sent.
  - **Note:** If geometry (Lines and Polygons) have been defined on the linked Defect, using Confirm-Connect, then these geometry details will be used instead of just the Job coordinates. If more than one Job is linked to a Street Work, and these Jobs have geometry data, then the 'Convex Hull' of the combined geometries will be used.

# Immediate Works Initial Notice

The following conditions on the Job will trigger the creation of this Notice. This Notice also serves as a notice of starting as the works is immediate and not planned.

• The Actual Start Date must be set. This is set automatically when the Job is changed to a status that has the *In Progress* check box ticked.

**Note:** The Actual Start Date will *not* be overwritten if it has been set already on the Job.

- The Job's Estimated End Date must be set.
- The Urgency on the Job's Priority must be set to Urgent or Emergency.

#### **Planned Works Initial Notice**

The type of Initial Notice created for a Planned Works is governed by the duration of the works as follows:

- 1-3 Days will create a Minor Notice
- 4-10 Days will create a Standard Notice
- 11+ Days will create a Major Notice

Note: If the Traffic Management field is set 'Road Closure', Works Type will be set to Major works

The following conditions on the Job will trigger the creation of this Notice.

- The Job's *Estimated Start Date* must be set. A date should be entered that that supplies enough of a notification period otherwise a early start agreement will be required and an 'i' icon indicator will be displayed next to the field to warn the user.
- The Job is set to a Job Status that has the *Initiate Street Works* check box ticked.
- The Job's Estimated End Date must be set.

After all Job conditions have been supplied the Notice will be created.

# **Planned Works Actual Start Notice**

Once a Planned Works has had an Initial Notice created an Actual Start Notice can be automatically generated.

The following conditions on the Job will trigger the creation of this Notice.

- An Initial Notice has been successfully created against the Job.
- The Job's *Actual Start Date* must be set. This can be done manually on the *Job* or *Order Job* screens or by changing the Job's status to one with the *In Progress* option enabled.

After all Job conditions have been supplied the Notice will be created.

#### **Error Correction Notice**

When one or more of the following conditions are changed on the Job an Error Correction Notice will be triggered.

- The Traffic Management field is changed.
- The Location field is changed.
- The Description field is changed.
- The Job Coordinates are changed.
- The Street (site) on the Job is changed.

**Note:** The notice will be created but will not send automatically as these types of Notices require agreements. Agreements have to be entered manually on the Street Works Notice.

# **Revised Duration / Confirmation Notice**

Revised Duration/Confirmation Notices are triggered differently depending on whether an Actual Start Date Notice has been created or not against the Job. These triggers are explained independently below.

#### **Confirmation: Works Has Not Started**

When one or more of the following conditions are changed on the Job a Confirmation Notice will be triggered.

- The Job's Estimated Start Date has changed.
- The Job's Estimated Completion Date has changed.

#### **Revised Duration: Works Has Already Started**

When both of these conditions are changed on the Job a Revised Duration Notice will be triggered.

• The Job's Estimated Completion Date has changed.

• The *Notes* field on the Job's *Current Status* tab have been updated. This is usually to explain why the duration has changed.

# **Works Stop Notice**

Once a Works has been started a Works Stop Notice can be automatically generated.

The following condition on the Job will trigger the creation of this Notice.

• The Job's *Actual Completion Date* must be set. This can be done manually on the *Job* or *Order Job* screens or by changing the Job's status to one with the *Complete* option checked on the Job Status Lookup.

After all Job conditions have been supplied the Notice will be created.

# **Cancellation Notice**

Cancellation Notices can only be generated for Works that have *not* been started.

The following condition on the Job will trigger the creation of this Notice.

• The Job is set to a cancellation Job Status. A cancellation Job Status is a status that has both its *Complete* and *Outstanding* options unchecked on the Job Status Lookup.

After all Job conditions have been supplied the Notice will be created.

# Viewing, Creating and Linking Notices From the Job Screen

# **VIEWING NOTICES**

Notices can be viewed from the Job and Order Job screens.

To do this the Job's *Job Type* must have its *Street Works Noticing* field set to anything other than *None Required*. This will ensure that the *Notice* button is enabled on the *Job* and *Order Job* screens.

Click on the *Notice* button and select the *Display Notice* option. Any Notices raised against the Job will be displayed.

If no Notices have been raised against the Job the *Display Notice* option will be greyed out.

#### Notice Visual Indicators

There are a couple of visual indicators that are displayed on the *Job* and *Order Job* screens when Notices are created.

- A green tick on the Notice button indicates that the last Notice was created successfully.
- A red cross on the Notice button indicates that the last Notice was unsuccessful.

**Note:** To see these indicators the *Show visual indicator of button contents* option must be ticked on the **General System Settings** screen

Notices can be created manually from the Job and Order Job screens.

To do this the Job's *Job Type* must have its *Street Works Noticing* field set to anything other than *None Required*. This will ensure that the *Notice* button is enabled on the *Job* and *Order Job* screens.

Click on the *Notice* button and select the *Create Notice* option. The appropriate Street Works Wizard will appear to create the required Notice.

# LINKING NOTICES

Notices that have already been created can be linked to a Job via the Job and Order Job screens.

To do this the Job's *Job Type* must have its *Street Works Noticing* field set to anything other than *None Required*. This will ensure that the *Notice* button is enabled on the *Job* and *Order Job* screens.

Click on the *Notice* button and select the *Link to Notice* option. A filter screen will appear to select a Notice to link to the Job. Note that any Notices already linked to a Job will not be available for selection.

The linked Notice can be viewed by selecting the *Display Notice* option from the *Notice* button.

# **UNLINKING NOTICES**

Notices can be unlinked from Jobs by selecting the *Clear Link to Notice* option from the *Notice* button.
